

- (1) Reporting time for document verification at Department of Chemical Engineering (Room no. 10) will be **9:00 AM** onwards on **December 13, 2022**.
- (2) All the Provisionally Eligible candidates are required to produce following certificates in **ORIGINAL** before Written examination failing which the candidates will not be allowed to appear for the written test/interview.
 - i. GATE Score card.
 - ii. All B. Tech. and M. Tech. Mark sheets/Grade cards and Degree Certificates.
 - iii. Proof of submission of M.Tech Dissertation at the time of interview in case qualifying degree result is not declared yet.
 - iv. Valid Caste Certificate, if applicable.
 - v. Document for proof of date of birth and a valid Photo ID proof.
- (3) At the time of document verification, the candidates are also required to submit self-attested copies of the documents mentioned in the remarks column against their name.
- (4) Written test consisting of multiple-choice questions based on Core Chemical Engineering Courses will be conducted for all the eligible candidates (after document verification). - (5) The candidates qualifying the written test will have to give presentation (of about 10-15 minutes) on the topic in which he/she aspires to pursue his/her research work followed by interview. Presentation/interview will be on the same day i.e. **December 13, 2022**.
- (6) All Full time sponsored candidates (FSC), Full time self-financed candidates (FSF), Part-time external candidates (PEC), and Full-time study leave candidates (FSL) must produce the required documents as specified in the advertisement of Ph.D. admission/as mentioned on the admission portal for Ph.D. admission.
- (7) External candidates must produce a relevant sponsorship certificate strictly as per the format given in **Appendix-III** (on the Ph.D. application portal), without which he/she will not be permitted for appearing in written test for the Ph.D. admission.
