SUB: Empanelment of Hospital for cashless / Credit tie up facility for regular employees of SVNIT, Surat

The Institute has signed agreement with Satva Hospital, Vesu, Surat for providing empanelment with cashless / Credit tie up facility (Indoor treatment) for regular employees of SVNIT, Surat w.e.f. 10.11.2023 for a period of two years. Accordingly, the updated list of empaneled Hospital for cashless / Credit tie up facility for regular employees of SVNIT, Surat as on date is as follows;

The Cashless Medical Treatment facility for all regular employees of the institute is available from the above Hospitals subject to the following conditions:

- (a) The above facility is only for IPD treatment through Referral System. In the normal circumstances, the employees have to utilize the OPD facility of the SVNIT Health Centre. The employees can approach the above hospitals for Inpatient Department (IPD) medical treatment only with a referral letter issued by the designated officer seal and signature of the Institute.
- (b) For availing cashless medical treatment facility, the eligible employee/ patient will be required to visit Chief Medical Officer at the Institute Health Centre. After medical examination of the patient, the CMO will recommend &forward the request for issue of referral letter to the Deputy Registrar (Establishment) of the Institute. After scrutiny, the referral letter will be issued by Establishment Section. All such work will be carried out on priority. The referral letter will be valid for indoor treatment at the designated hospital for 15 days from the date of issue.
- (c) In exceptional circumstances and emergency conditions, the above Hospitals shall admit patients from SVNIT, Surat without referral letter. In such situations, the employee shall have to produce the referral letter to the Hospital Authorities within 24 Hours of admission. In such conditions the employees are required to produce their identity Card and other proof before the hospital administration at the time of admission.
- (d) The institute will make payment against the admissible medical treatment charges directly to the hospitals only.

  [Mathematical treatment charges directly to the hospitals only.]

- (e) The cashless Medical Facility will be available in the above Hospitals for all type of inpatient treatment for which rates are provided under CGHS/AIIMS and facilities available with the hospitals. The reimbursement of expenditure for Consultant/ treatment including hospitalization will be limited to rates as fixed under CGHS or actual whichever is less.
- (f) The charges for non-admissible items/services/facilities availed by the patient/employee shall be borne by the patient/employee concerned and directly paid to the hospitals by the referred employee/dependent. The institute shall not reimburse the charges paid for non-admissible items/services/facilities availed by the patient/employee including the inadmissible medicines viz. Vitamins/ Nutritional Supplements, toiletries etc. as listed in the Inadmissible Category by CS (MA) / CGHS.
- (g) The employee/ dependent referred for indoor treatment will be required to sign all the bills of the hospitals before discharge and should co-operate with the hospital authorities for processing their claims at SVNIT Surat.
- (h) The Medical reimbursement for hospitalization at other empanelled hospitals (other than Sr. No 01 to Sr. No. 05 listed above) will continue as per CGHS rates on reimbursement claim basis. However this will be without any Cashless/ Credit Tie-up provision.

This will supersede the Circular No. E/1448 dtd. 31.03.2021.
