The quotations should be furnished with the following information.

- The work order is for a period of <u>30 days</u> from the date of issue of a confirmed work order.
- 2. The rates specified in the quotation are for making of Pole Foundation for LED Floodlight work on a **F.O.R. Institute** basis.
- GST and any additional charges such as transportation F.O.R. SVNIT should be clearly specified at the concessional rates allowed to educational institutions as per the relevant notification of the Government.
- 4. The period of validity of the quotation should be at least 45 Days. Offer subject to a prior sale may please be avoided.
- 5. Payment shall be made within a period of thirty days from the date of satisfactory completion of the work & submission of bills and official procedure from the account section of the institute.
