The quotations should be furnished with the following information:

1. Attested copy of the valid Registration Certificate of GST & PAN.
2. Attested copy of the valid Registration Certificate of Registered Contractor/Registered Shop.
3. The rates specified in the quotation are for Purchase of "12 meter GI poles" for Tennis Court Ground on a **F.O.R. Institute** basis.
4. GST and any additional charges such as transportation F.O.R. SVNIT should be clearly specified at the concessional rates allowed to educational institutions as per the relevant notification of the Government.
5. The supply period is to be clearly mentioned in the quotation.
6. The supply order is for a period of **30 days** from the date of issue of a confirmed supply order.
7. The period of validity of the quotation should be at least 90 Days. Offer subject to a prior sale may please be avoided.
8. Payment shall be made within a period of thirty days from the date of satisfactory completion of the supply & submission of bills and official procedure from the account section of the institute.
9. All concessions available to an educational institution should be specified and also taken into account while quoting.
10. The mode of supply must be mentioned. The supply should be at F.O.R. SVNIT, Surat.
11. An offered quotation may be rejected if any ambiguity is found.
12. The supply will be executed under the direct supervision of the Estate (Electrical) Section.




16. Warranty/Guarantee: As per company norms.

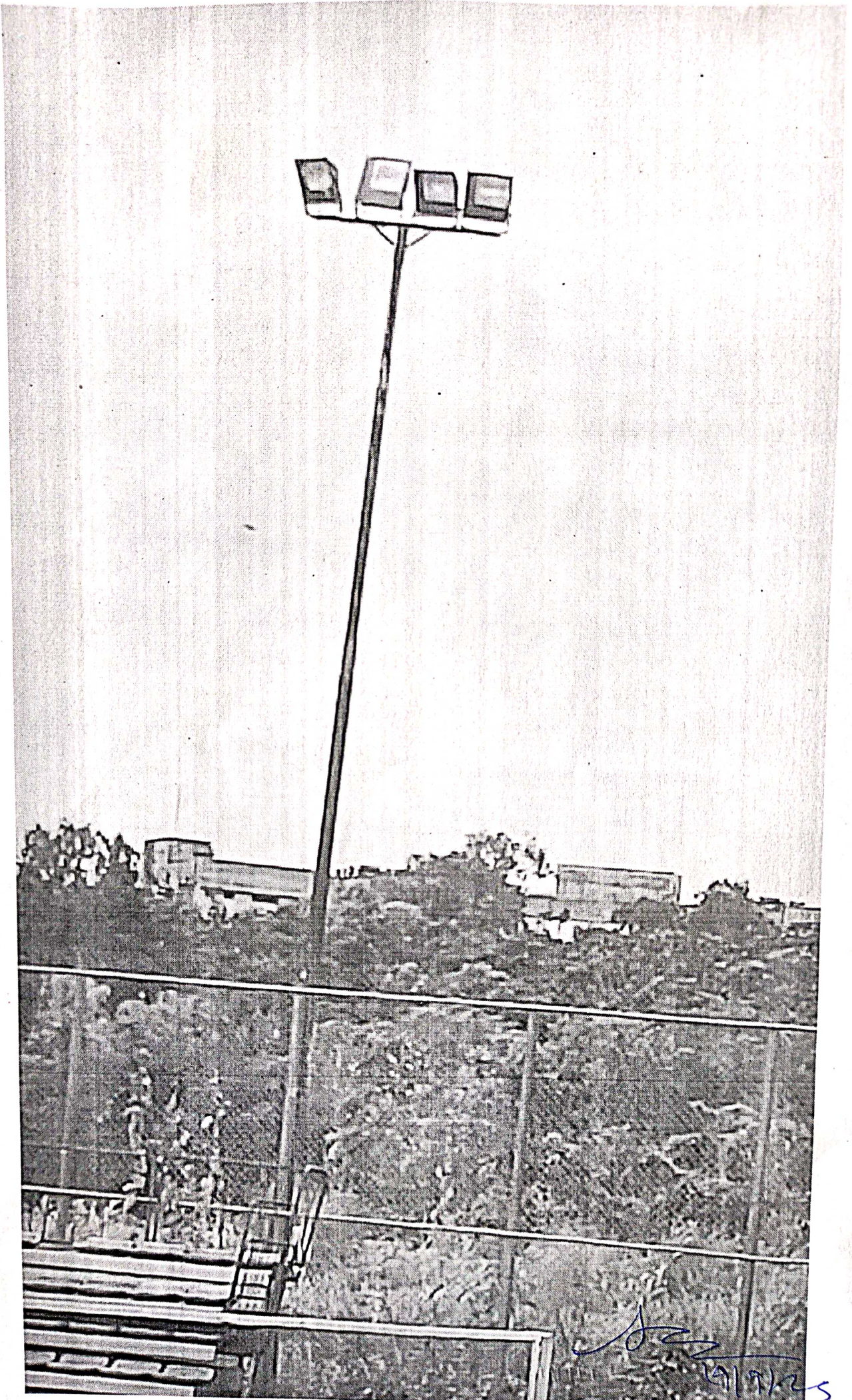
