- 2. All the Eligible and Provisionally Eligible candidates must bring all the necessary ORIGINAL DOCUMENTS as mentioned in the information of Ph.D. admissions portal at the time of document verification.
- 3. Candidates will not be allowed to appear in the Written Test/ Interview without any of the required Original Document and no reason/excuse will be entertained.
- 4. All the candidates must bring one set of Xerox copies of all the necessary documents at the time of document verification.
- 5. Candidates applied in ERS category and working in any Institute/Organization must bring the following documents:
  - i Appointment letter issued by the current employer (Permanent appointment order with all necessary information about Basic Salary, HRA, DA, etc.)
  - ii Experience Certificate
  - iii Salary Certificate and Slip of last 12 months (with all necessary information about Basic Salary, HRA, DA, etc.)
  - iv Income Tax return or Form 16 of last Financial Year

Provisionally Eligible candidates are required to submit the documents as mentioned in # application.

Valid OBC-NCL certificate, issued on or after 01/04/2024 is to be produced at the time of document verification, for the consideration of the application in OBC-NCL category failing which the application will be considered in OPEN category.

CAT/NET score sheets required at the time of document verification.

Xerox copy of all semester marksheet and Degree certificate along with proof of first class is \*\*\* required at the time of document verification.

Valid EWS certificate is essential for those who have applied in EWS category.

### Note:

1. Vacancy in FIR category may vary.

All the candidates must qualify the written test for appearing in the interview.

3. All the candidates are required to remain present on 12/12/2024 at 9.00 a.m. in the Department of Mathematics (Near Canteen, Opposite to Institute Ground) with all the necessary original documents.

4. The written test will be of descriptive in nature covering various aspects of Management courses and Research immediately after document verification.
