The SC/ST/OB candidates of Maharashtra State have to produce their caste validity certificate in the exact format available on CCMT website (http://ccmt.nic.in)

 - xi. Original Certificate for Persons with Disabilities (PwD), if applicable, issued by the competent authority in required format (http://ccmt.nic.in)

 - xiv. Three color passport size photographs
