
The FIR candidates are required to bring the following **ORIGINAL** documents along with their **self-attested photocopies**

6. Degree/ Provisional certificate (M.E./M. Tech).
7. GATE scorecard
8. Certificate of category (SC/ST/OBC-NCL/EWS) issued by the competent authority. In case of the OBC-NCL/EWS category, the certificate must be issued on or after April 01, 2025.
9. Two passport-size recent photographs.
