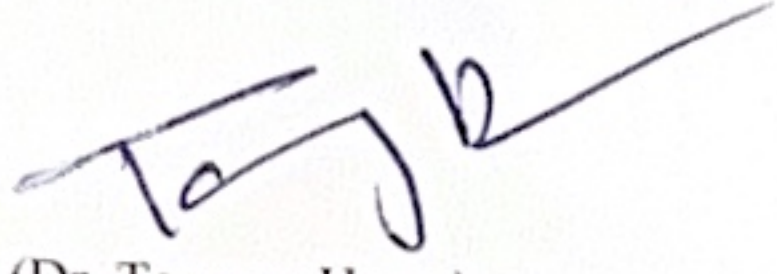
Instructions for Candidates:

2. All (Eligible and Conditionally Eligible) candidates must produce the required certificates in **ORIGINAL** as mentioned in the Institute's Ph.D. Application Portal during document verification; failure to do so will result in disqualification from the presentation & interview.
3. All (Eligible and Conditionally Eligible) candidates must bring one set of clear **Self-Attested Photocopies** of the necessary documents as mentioned in the Institute's Ph.D. Application Portal.
4. Candidates belonging to the **OBC-NCL & EWS category** are required to produce the latest (valid) certificate as per the Central Government Format.
5. The candidate's qualifying written test will have to give a presentation (of about 10-12 minutes) on the tentative topic in which he/she aspires to pursue his/her Ph.D. Program followed by an interview. **Presentation/Interview will be on the same day i.e. 15th May 2025.**
