


- GATE/NET/CAT Score card (if applicable).

- Certificate of category (SC/ST/OBC-NCL/EWS) issued by the competent authority.
In case of OBC-NCL/EWS category, the certificate must be issued on or after 1st April 2025.
- Document for proof of date of birth and a valid Photo ID proof as per Govt. of India norms.

- Recent passport size photograph.


(3) At the time of document verification, the candidates are also required to submit self-attested copies of the documents mentioned in the remarks column against their name.


