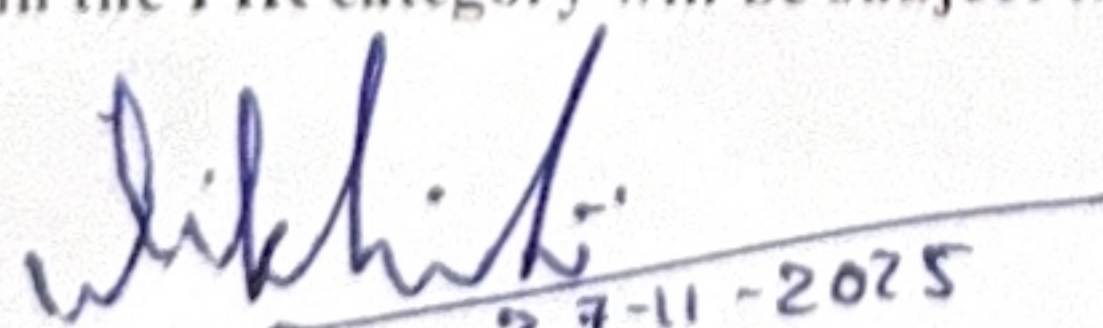
- All eligible and provisionally eligible candidates must report to the **Office, Centre for Tribal Technology Development (Above Central Canteen) on 10th December 2025 (Wednesday) by 2:00 PM** for document verification and the selection procedure.
 - All eligible and provisionally eligible candidates must produce the required certificates and documents in **ORIGINAL** and **one set of clear self-attested photocopies**, arranged as per the serial given below, as mentioned in the Institute's Ph.D. Application Portal, during the Document Verification Stage. Failure to do so will result in disqualification from the written test and/or interview. List of the Documents as below
 - SVNIT Ph.D. Application Form.
 - One Passport-Size recent photograph.
 - Photo ID (As per Government of India norm).
 - Class X / Matriculation Mark Sheet.
 - Class XII / Intermediate Mark Sheet
 - Graduation Degree Mark Sheets (All Semesters) & Certificate
 - Post-Graduation Degree Mark Sheets (All Semesters) & Certificate.
 - GATE/UGC-NET in English Qualifying Certificate (If Applicable).
 - Category Certificate (SC/ST/OBC-NCL/EWS) issued by the Competent Authority (for OBC-NCL/EWS, issued on or after April 1, 2025).
 - Disability Certificate issued by the Competent Medical Authority.
 - For ERS Candidates:
 - Appointment letter issued by the current employer.
 - Experience certificate duly signed by the competent authority on the letterhead of the Company/Organisation/Institute.
 - Salary certificates/slips for the last 12 months.
 - Income-Tax Return or Form-16 of the last financial year.
 - Sponsorship/No Objection Certificate.

Note: The sponsorship certificate should be from the same organisation that issued the appointment letter, experience certificate, and salary slip.

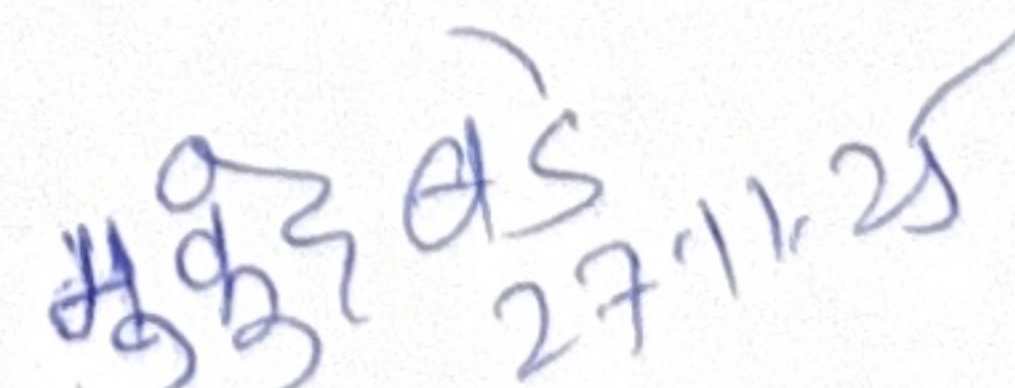
