- 6. The CEA and Hostel Subsidy is admissible in respect of Children studying from two classes before class one to 12th/10+2 standard or till the child attain the age of 20 years, whichever is earlier. For Divyang Children the upper age limit will be 22 years.
- 7. The deadline for submission of application is 11th March, 2023 of the Academic Year 2023-24 with all certificates to Deputy Registrar (Establishment).
