All Employees/ Pensioners who have chosen the <u>Old Tax Regime</u> are requested to <u>mandatorily</u> submit <u>Self Declaration Form along with concrete Evidence of Investment</u> (if no evidence is provided, the <u>submitted claim shall not be taken into consideration</u>) to the Account Section on or before <u>31.12.2024</u>, failing which Income Tax will be deducted by the Account Section as per New Tax Regime by default.
