**1. Essential/ Desirable Qualification/Specialization, Age and Experience:**

The essential/ desirable qualifications/Specialization age and experience for the above posts are as per Recruitment Rules (2019) for Non-teaching staff in NITs, available at **ANNEXURE-I**. The applicants are advised to refer the same before filling the online application form.

## 2. Age Limit and applicable Relaxation:

- (a) Maximum age limit for each post shall be as per Recruitment Rules of NITs.
- (b) Persons currently engaged at SVNIT, Surat on Ad-hoc /Temporary / Contractual / Outsourced basis, are allowed **one-time age relaxation upto the age of 56 years**, to participate in this regular recruitment process for the posts for which they fulfill all other conditions including educational qualifications mentioned in the Recruitment Rules (2019), subject to the following conditions:

- VI. The period of Experience rendered by a candidate on part-time basis /daily wages or as visiting / guest faculty will not be counted while calculating the valid experience for shortlisting the candidates to appear for Selection Test/ Interview.

- VII. The Caste/Tribe/Community certificates in the proforma prescribed and issued by the DOPT, Govt. of India vide letter no.F.No.36028/1/2014-Estt. (Res.) dated 3<sup>rd</sup> September, 2015 will only be accepted as sufficient proof in support of an applicant's claim as belong to Schedule Caste/ Schedule Tribe/ Other Backward Class. - VIII.
