Note for Eligible Candidates:

- 1. The candidature is **PROVISIONAL**. If at any stage it is found that any applicant does not fulfill any of the conditions of eligibility, his / her candidature will be cancelled and no appeal against such cancellation will be entertained. The fact that he / she has been called for the test does not confer any right on him / her to be treated as eligible in all aspects for appointment or to be considered for the test. No TA / DA for attending the test will be provided.
- 2. The Written Test for the eligible candidates for the post of Pharmacist are scheduled to be held on <u>March 4</u>, <u>2023 (Saturday) at SVNIT, Surat at 3:00 P.M</u>. The detailed schedule is enclosed as Appendix-A.
- 3. The candidates can download the e-Admit cards for appearing in the Written Test Paper-I from February 15, 2023. The eligible candidates are advised to download the e-Admit Cards as per the following procedure:
 - i. Visit the link
 - ii. Login using same USERNAME that was generated at the time of submission of application form online.
 - iii. After Login with Password, click on the tab e-Admit Card to generate the e-Admit Card.
 - iv. In case the e-ADMIT Card does not get displayed, the candidate shall allow the pop-up in the browser and generate the e-Admit Card again.
 - v. Take the print out of the e-ADMIT Card, preferably on Color Printer.
 - vi. In case of any queries / difficulties in downloading the Admit Card, the candidates are advised to contact us on <u>svnit.recruitmentphm@svnit.ac.in</u> with a copy to <u>svnit.recruitmentphw@svnit.ac.in</u>
- 4. No candidates shall be allowed to enter the institute without Hard copy of e-Admit Card supported by valid ID Proof.
- 5. The instructions regarding the conduct of tests are given on the e-ADMIT card. The candidates in their own interest are advised to go through those instructions required for appearing in the Recruitment Written Tests.
- 6. It is to be noted that Mobile Phones or any electronic gadgets will not be allowed inside the exam hall. The institute will not be responsible for keeping any mobile or any electronic gadgets or any associated loss of mobile / electronic gadgets. Mobile scanner will be used and if any applicant is found to have mobile / electronic gadgets inside examination hall, his/her test will be cancelled.
- 7. All students appearing in the said tests are advised to follow COVID appropriate behaviors and any other instruction issued by UT Govt. / Government of India. Candidates who are not observing the COVID appropriate behaviors shall not be allowed to appear in the Recruitment Written tests.
- 8. All the eligible candidates have to produce following (copy attached).
 - Recent No Objection Certificate from present employer. (If applicable)
 - The candidates working in PSUs / Industries / State Government having different pay structure will be required to produce equivalency certificate of his/her pay scale/Grade Pay from their present employer as per Govt. of India pay structure.
 - The original certificates for their educational qualification and relevant experience mentioned in their application form.
 - Proof of Identity issued by the Govt. (in Original) such Aadhar Card / Passport / Driving License / PAN Card / Voter Card.
 - The person working in a Government, Semi Government, Autonomous organization including Public Sector Undertakings etc. and whose application has not been forwarded through proper channel by the employer will be required to bring a 'No Objection Certificate' along with 'Vigilance Clearance Certificate' from the present employer. In the absence of No Objection Certificate and other certificate their candidature will not be considered.

- 9. The Number of posts as mentioned in Advt. may change and may vary at the time of personal selection/recruitment. The Institute reserves the right not to fill any/ all posts advertised and to reject any/all application without assigning any reason.
- 10.
