Note for Eligible Candidates:

1. The candidature is **PROVISIONAL**. If at any stage it is found that any applicant does not fulfill any of the conditions of eligibility, his / her candidature will be cancelled and no appeal against such cancellation will be entertained. The fact that he / she has been called for the test does not confer any right on him / her to be treated as eligible in all aspects for appointment or to be considered for the test. No TA / DA for attending the test will be provided.
2. The Written Test for the eligible candidates for the post of Scientific Officer is scheduled to be held on **March 4, 2023 (Saturday) at SVNIT, Surat at 2:00 P.M.** The detailed schedule is enclosed as **Appendix-A**.
3. The candidates can download the e-Admit cards for appearing in the Written Test from February 15, 2023. The eligible candidates are advised to download the e-Admit Cards as per the following procedure:
 - i. Visit the link <https://svnintrecruitment.mastersofterp.in/>
 - ii. Login using same USERNAME that was generated at the time of submission of application form online.
 - iii. After Login with Password, click on the tab e-Admit Card to generate the e-Admit Card.
 - iv. In case the e-ADMIT Card does not get displayed, the candidate shall allow the pop-up in the browser and generate the e-Admit Card again.
 - v. Take the print out of the e-ADMIT Card, preferably on Color Printer.

4. Those candidates who will be shortlisted based on Written Examination Marks and Document Verification shall be eligible for personal Interview. However, the final selection will be based on performance in the personal Interview only. No request for relaxation for submission of documents/ change of venue/ date of examination/ interview shall be considered under any circumstances.
5. The candidates are advised to report at the venue one hour before the examination. The document verification process will start immediately after displaying of shortlisted candidates after the written examination. The final result for written examination will be displayed on the institute website and notice board by the Institute on the same day at later evening.
6. No candidates shall be allowed to enter the institute without Hard copy of e-Admit Card supported by valid ID Proof.
7. The instructions regarding the conduct of tests are given on the e-ADMIT card. The candidates in their own interest are advised to go through those instructions carefully before appearing for the Written Tests.
8. It is to be noted that Mobile Phones or any electronic gadgets will not be allowed inside the exam hall. The institute will not be responsible for keeping any mobile or any electronic gadgets or any associated loss of mobile / electronic gadgets. Mobile scanner will be used and if any applicant is found to have mobile / electronic gadgets inside examination hall, his/her test will be cancelled.
9. All students appearing in the said tests are advised to follow COVID appropriate behaviors and any other instruction issued by State Govt. / Government of India. Candidates who are not observing the COVID appropriate behaviors shall not be allowed to appear in the Recruitment Written tests.

10. All the eligible candidates have to produce following documents at the time of interview (copy attached).
- Recent No Objection Certificate from present employer (**if applicable**)
 - Recent duly signed Original Endorsement Certificate (**ANNEXURE-I**) from present employer alongwith **ANNEXURE-II** for providing information related to Pay Scale, Grade Pay & Experience of applicants at the time of interview. (copy attached).
 - The candidates working in PSUs / Industries / State Government having different pay structure will be required to produce equivalency certificate of his/her pay scale/Grade Pay from their present employer as per Govt. of India pay structure.
 - The original certificates for their educational qualification and relevant experience mentioned in their application form.
 - Proof of Identity issued by the Govt. (in Original) such Aadhar Card / Passport / Driving License / PAN Card / Voter Card.
 - The person working in a Government, Semi Government, Autonomous organization including Public Sector Undertakings etc. and whose application has not been forwarded through proper channel by the employer will be required to bring a '**No Objection Certificate**' along with '**Vigilance Clearance Certificate**' from the present employer at the time of interview. In the absence of **No Objection Certificate** and other certificate their candidature will not be considered.
