## Corrigendum - Rolling advertisement for Recruitment of Associate Professor

As per Gazette Notification dated 19<sup>th</sup> June, 2023 regarding First Statutes of the National Institutes of Technology (Amendment) Statutes, 2023 of the SVNIT Surat (the details are annexed), all clarifications issued from MoE on 13<sup>th</sup> September, 2017; 30<sup>th</sup> November, 2017; 4<sup>th</sup> December, 2017; 31<sup>st</sup> January, 2018; 20<sup>th</sup> April, 2018; and 16<sup>th</sup> April, 2019 is applicable in conjunction with qualifications and other terms and conditions of appointment of academic staff specified under Schedule E. However, all other terms and conditions of the advertisement including eligibility criteria, age limit, qualification etc. for applying for the posts shall remain unchanged. As a consequence of implementation of above notification, the candidates will be required to provide additional information in support of his/her candidature and provide all related credentials to claim their eligibility as per modified criteria for recruitment as per gazette notification. Prof./212 dated 17.04.2023 for the post of Associate Professor (Pay Level 13A) and wish to modify the same, are advised to send a request through email at **facultyrecruit2023@svnit.ac.in** with a copy to **dean\_fw@svnit.ac.in** to unlock their accounts, thus enabling them to resubmit the online application. The candidates who have already submitted the hard copy, are advised to resubmit the modified version of the application by the stipulated date. The last date for submission of online application is 21<sup>st</sup> July (5PM) and submission of hard copy of the applications is 31<sup>st</sup> July 2023 (5.00 PM) for first round of recruitment.

It must be noted that the candidates' application only in soft copy will not be entertained and will be summarily rejected if the hard copy of the application form, along with other requisite self-attested photocopies of the relevant documents, is not received at the Institute within the stipulated date & time. If at any stage, the submissions made by the candidate is found to be faulty or non-genuine, the candidature of such candidate shall be cancelled and shall not be considered for future recruitment process.

The date for determining the eligibility of candidates in every respect, i.e., qualification, experience, preferred age limit, etc., shall be considered the closing date of the first round of rolling advertisement online application, i.e.  $21^{st}$  July 2023.
