Important Instructions for Eligible/Provisionally Eligible/Not-Eligible Candidates Department of Electrical Engineering & Department of Electronics Engineering

- 1. The applications received for the post of Assistant Professor (Level 11) till the last date have been scrutinized.
- 2. The displayed lists of eligible, conditionally eligible, and not eligible candidates are provisional.
- 3. The eligibility of the candidates is assessed as per Schedule 'E' of the NIT Statute, published in the Gazette of India on 24th July 2017 and 19 June, 2023
- 4. The date and schedule for the written examination/presentation/personal interview shall be notified on Institute website in due course of time.
- 5. Eligible Candidates:
 - a. A candidate belonging to the SC/ST/OBC(NCL)/EWS category has to produce an original certificate as mentioned in the advertisement notification at the time of the written test/interview, failing in doing so, his/her candidature will be considered in the UR category only, and he/she has to pay the application processing fee as per the UR category.
 - b. The person employed on regular employment in Government, Semi-Government organizations, the Public Sector, Autonomous bodies of the Govt. of India, or the State Government must bring an original copy of No Objection Certificate (NOC) at the time of the written test/interview, if it is not submitted with the application form or not applied through the proper channel; failing in doing so, his or her candidature may be cancelled.
 - c. All the necessary documents/certificates in original have to be produced for verification at the time of written exam/interview, failing in doing so, his/her candidature for further process of recruitment stands cancel.
- 6. Conditionally eligible: A candidate who is conditionally eligible needs to submit the supporting documents from their registered email-id given in the application form on or before 27 July 2023 up to 5.30 pm via email to faculty_11@svnit.ac.in, failing in doing so, his/her candidature for the recruitment will not be considered. In the email, candidate must mention full name, Application ID, and department name clearly.
- 7. Not-Eligible candidates: If any query is there from the Not-Eligible candidate, he/she may submit his/her representation(s) along with authentic documentary evidence from their registered email-id given in the application form on or before 27 July 2023 up to 5.30 pm via email to faculty_11@svnit.ac.in, failing in doing so, his/her candidature for the recruitment will not be considered. In the email, candidate must mention full name, Application ID, and department name clearly.
- 8. The Institute shall not be responsible for any error/omission/commission/suppression of any information provided by the applicants, knowingly or unknowingly, while filling up the application form. In case the applicant gets shortlisted/selected on the basis of incorrect, forged, or fabricated details, his/her candidature shall be liable to be cancelled at any stage of recruitment or during the tenure of service, and appropriate legal action under applicable law shall be initiated against such applicants. The Institute reserves the right to alteration/modification/correction in the list of eligible, provisionally eligible, and not-eligible candidates.
- 9. Mere appearance in the Written Test / Interview doesn't entitle a candidate to be considered for selection. APPLICANTS MUST FULLY SATISFY ABOUT THEIR ELIGIBILITY AS PRESCRIBED ON OUR WEBSITE BEFORE APPEARING IN THE TEST. If candidate is inadvertently allowed to appear in the written test/Interview who otherwise doesn't fulfil the minimum eligibility requirements, the candidate can't, at a later date, use this as a right to claim that candidate meets the eligibility requirements. The Institute reserves the right not to allow a candidate for selection if it is found that
 - a. Minimum eligibility requirements are not fulfilled.
 - b. Inadequate proof / false documentation has been done.
 - c. Non-submission of valid NOC
 - d. Any other similar valid reasons.
