6.	Age Limit	Not more than 45 years as on last date of application
7.	<b>Job Profile: -</b> <ul style="list-style-type: none"><li>• He/She has to attend duty at Institute Health Center to provide medical treatment to the residents/ students of the Institute.</li><li>• He / she should be able to provide emergency services as and when required.</li><li>• In case of medical emergency he / she should be available on call basis.</li><li>• Job Profile mentioned above is illustrative. Roles/Jobs in addition to the above mentioned may be assigned by the Institute from time to time for the above post.</li></ul>	
8.	<b><u>Educational qualification and Experience:</u></b> Essential: <b><u>Educational qualification:</u></b> MBBS Degree or equivalent qualification included in any one of the Schedules to the Indian Medical Council Act, 1956 (102 of 1956) and must be registered in a State Medical Register or Indian Medical Register. <b><u>Desirable:</u></b> Post Graduate Qualification, preferably MD in General Medicine or equivalent qualification included in any one of the Schedules to the Indian Medical Council Act, 1956 (102 of 1956) and must be registered in a State Medical Register or Indian Medical Register. Note: i) The Medical qualifications possessed by the candidates should have the recognition of the Medical Council of India. ii) Completion of compulsory Rotating Internship Certificate, [Registration Certificate, an official document showing name of College / Institution from where degree / diploma has been done and official document showing name of the institution from where experience has been gained are required.]

10.	<b><u>Selection Process:</u></b> The interested candidates may appear for Walk-In-Interview on <b>09.11.2023</b> . The final selection will be based on the performance of candidate during personal interview at SVNIT Surat.

The engagement would be purely on contractual basis. <b>Any</b> claim for absorption at the regular position in the institute will not be entertained at any point of time.</li> <li>ii. The engagement will be subject to their medical fitness.</li> <li>iii. The Institute reserve the right to terminate the services of the appointee at any time by giving one month's notice or payment of one month's salary in lieu thereof by either side without assigning any reason.</li> <li>iv. The incumbents shall be eligible for 8 days of casual leave in a calendar year. Any other leave shall not be admissible.</li> <li>v. The appointee will not be entitled for any medical facility/ accommodation or any other type of allowances.</li> <li>vi. The appointees have to attend the office six days a week.</li> <li>vii.
