1. Essential/ Desirable Qualification, Age and Experience:

2. Age Limit and applicable Relaxation:

- I. Maximum age limit for each post shall be as per Recruitment Rules of NITs.
- II. For the post of Dy. Librarian Persons currently engaged at SVNIT, Surat on Ad-hoc /Temporary / Contractual / Outsourced basis engaged through various service provider and institute daily wages basis having one year of service at SVNIT Surat, are allowed
