The details regarding eligibility criteria, terms of references etc. are as follows:

3.	Nature of engagement	Contractual
4.	Method of Recruitment	Purely on contract basis for one year which may be extended further for one year based on performance of the candidate.
5.	Monthly Pay / Remuneration	Consolidated Rs 60,000/- per month
6.	Age Limit	Not more than 45 years as on last date of application
7.	Job Profile: - <ul style="list-style-type: none">• He/She have to attend duty at Institute Health Center to provide medical treatment to the residents/ students of the Institute.• He / she should be able to provide emergency services as and when required.• In case of medical emergency he / she should be available on call basis.• Job Profile mentioned above is illustrative. Roles/Jobs in addition to the above mentioned may be assigned by the Institute from time to time for the above post.	
8.	<u>Educational qualification and Experience:</u> Essential: <u>Educational qualification:</u> MBBS Degree or equivalent qualification included in any one of the Schedules to the Indian Medical Council Act, 1956 (102 of 1956) and must be registered in a State Medical Register or Indian Medical Register. <u>Desirable:</u> Post Graduate Qualification, preferably MD in General Medicine, or equivalent qualification included in any one of the Schedules to the Indian Medical Council Act, 1956 (102 of 1956) and must be registered in a State Medical Register or Indian Medical Register. Note: i) The Medical qualifications possessed by the candidates should have the recognition of the Medical Council of India. ii) Completion of compulsory Rotating Internship Certificate, [Registration Certificate, an official document showing name of College / Institution from where degree / diploma has been done and official document showing name of the institution from where experience has been gained are required.]	
9.	<u>Application Process:</u> The eligible interested candidates have to download the application form and submit the hard copy of their filled in applications through Speed/ Registered Post in prescribed format with copies of certificates & Mark-sheets, to The Deputy Registrar (Establishment), Sardar Vallabhbhai National Institute of Technology, Surat, Ichchhanath, Dumas Road, Keval Chowk, Surat, Gujarat-395007 so as to reach on or before 29th September 2023 . The envelop should superscribed as Application for the Post of Medical Officer on Purely Contract Basis (Last Date 29th September 2023).	
10.	<u>Selection Process:</u> The shortlisted candidates will be called for interview. The final selection will be based on the performance of candidate during personal interview at SVNIT Surat. Mere fulfilling minimum qualification and experience will not vest any right in candidate for	

	being called for interview. The shortlisting parameters will be decided by the Institute and thereafter, adequate number of candidates, as decided by the Institute, will be shortlisted for interview. The decision of the Institute Authorities shall be final. No correspondence will be entertained in this regard.
11	<p><u>General Instructions & Other Information :</u></p> <ol style="list-style-type: none"> i. The engagement would be purely on contractual basis. Any claim for absorption at the regular position in the institute will not be entertained at any point of time. ii. The engagement will be subject to their medical fitness and police verification. iii. The Institute reserve the right to terminate the services of the appointee at any time by giving one month notice or payment of one month salary in lieu thereof by either side without assigning any reason. iv. The incumbents shall be eligible for 8 days of casual leave in a calendar year. Any other leave shall not be admissible. v. The appointee will not be entitled for any medical facility/ accommodation or any other type of allowances. vi. The appointees have to attend the office six days a week. vii. In case of exigencies of the work, the appointee shall be required to attend the duty on Holidays. No extra remuneration shall be admissible for the same. viii. The Headquarters of the appointee shall be at Surat. ix. The Institute reserves the right to impose any other reasonable conditions to safeguard the interest of the Institute. x. Any resultant dispute shall be settled within the jurisdiction of Surat. xi. The closing date for submission of applications shall be considered as the cut-off date of age, educational qualifications and experience. xii. The Institute reserves the right to assign / transfer the selected candidates to any section/ department within the Institute. xiii. No TA/DA shall be admissible for appearing in the written test/ Interview/ joining at SVNIT, Surat. xiv.
