## **Notes for the Shortlisted Candidates:**

- 1. The candidature is **PROVISIONAL**. If at any stage it is found that any applicant does not fulfill any of the conditions of eligibility, his / her candidature will be cancelled and no appeal against such cancellation will be entertained. The fact that he / she has been called for the test does not confer any right on him / her to be treated as eligible in all aspects for appointment or to be considered for the test. No TA / DA for attending the Interview will be provided.
- 2. Candidates are required to report at the Department for Document Verification followed with Departmental Presentation, one hour prior to the scheduled time. No candidates shall be allowed for presentation in the Department without valid ID Proof.
- 3. DOCUMENT VERIFICATION OF THE CANDIDATES IS MUST. Any candidate abstaining for document verification will be disqualified and loose his/her candidature for the post. Further, all the Shortlisted candidates have to produce following documents:
  - The person working in a Government, Semi Government, Autonomous organization including Public Sector Undertakings etc. and whose application has not been forwarded through proper channel by the employer will be required to bring a 'No Objection Certificate' from the present employer. In the absence of No Objection Certificate and other certificate their candidature will not be considered.
  - ➤ The original certificates for their educational qualification, Caste Certificate, relevant experience Certificate, Proof of Date of Birth, mentioned in their application form.
  - ➤ Proof of Identity issued by the Govt. (in Original) such Aadhar Card / Passport / Driving License / PAN Card / Voter Card.
  - > Candidates are required to bring one set of self-attested photocopy of all above documents.
- 4. Personal Interview of the shortlisted candidates will be conducted in the Institute's Guest House (SVP Bhavan) as per schedule mentioned above. Candidates have to report one hour before the stipulated time at the Venue for the Personal Interview.
- 5. The Number of posts shown in Advt. may change and may vary at any time during the recruitment process. The Institute reserves the right not to fill any/ all posts advertised and to reject any/all application without assigning any reason.
- 6. Mere appearance in the Departmental Presentation and Interview doesn't entitle a candidate to be considered for selection unless candidates fulfills the eligibility conditions and produce all the required documents at the time of document verification. The candidates must fully satisfy about their candidature for fulfilling the eligibility criteria as per advertisement.
