Notes for the Shortlisted Candidates for Document Verification and Personal Interview:

- 1. The written Examination is only qualifying in nature. The candidature of the shortlisted candidates after Written Examination is **PROVISIONAL**. If at any stage it is found that any shortlisted candidate does not fulfill any of the conditions of eligibility, his / her candidature will be cancelled and no appeal against such cancellation will be entertained.
