**Important Instructions for Eligible/Provisionally Eligible Candidates**

**For upgradation of internal Faculty Members from pay level 10 to level 11**

**Ref: No. E/2026/Notice-Upgradation AP (Gr-II)/2557 Dated: January 12, 2026**

1. The applications received for upgradation of internal Faculty Members from pay level 10 to level 11 till the last date have been scrutinized.
2. The displayed lists of eligible, conditionally eligible, and not eligible candidates are provisional.
3. The eligibility of the candidates is assessed as per Gazette Notification dated 19th June, 2023 regarding First Statutes of the National Institutes of Technology (Amendment) Statutes, 2023 of the SVNIT Surat, all clarifications issued from MoE on 13th September, 2017; 30th November, 2017; 4th December, 2017; 31st January, 2018; 20th April, 2018; and 16th April, 2019, F. No.33-9/2022-TS.III dated 29.11.2024 and Schedule 'E' of the NIT Statute, published in the Gazette of India on 24th July 2017 and 19 June, 2023.
4. **The date and schedule for the personal interview shall be notified on Institute website or via email in due course of time.**
5. **Eligible Candidates:**
  - a. A candidate belonging to the SC/ST/OBC(NCL)/EWS category has to produce an original certificate as mentioned in the Notice at the time of the personal interview, failing in doing so, his/her candidature will be considered in the UR category only. **The OBC(NCL) and EWS certificate should be issued after 31 March 2025.**
  - b. All the necessary documents/certificates in original have to be produced for verification at the time of document verification before the personal interview, failing in doing so, his/her candidature for further process of recruitment will stand cancel.
6. The Institute shall not be responsible for any error/omission/commission/suppression of any information provided by the applicants, knowingly or unknowingly, while filling up the application form. In case the applicant gets shortlisted/selected on the basis of incorrect, forged, or fabricated details, his/her candidature shall be liable to be cancelled at any stage of recruitment or during the tenure of service, and appropriate legal action under applicable law shall be initiated against such applicants. The Institute reserves the right to alteration/modification/correction in the list of eligible, provisionally eligible, and not-eligible candidates.
7. Mere appearance in the personal Interview doesn't entitle a candidate to be considered for selection. **APPLICANTS MUST FULLY SATISFY ABOUT THEIR ELIGIBILITY AS PRESCRIBED ON OUR WEBSITE BEFORE APPEARING IN THE INTERVIEW.** If candidate is inadvertently allowed to appear in the personal Interview who otherwise doesn't fulfil the minimum eligibility requirements, the candidate can't, at a later date, use this as a right to claim that candidate meets the eligibility requirements. The Institute reserves the right not to allow a candidate for personal Interview/selection if it is found that
  - a. Minimum eligibility requirements are not fulfilled.
  - b. Inadequate proof / false documentation has been done.
  - c. Any other similar valid reasons.
