8.	Educational qualification and Experience: Essential Qualifications & Experience: - Bachelor's degree in Law (LLB) from recognized Indian University Desirable Qualifications & Skills: - Master's degree in Law (LLM) from recognized Indian University	
9.	<u>Application Process:</u> The eligible interested candidates have to download the application form and submit the hard copy of their filled in applications through Speed Post/Courier/Hand delivery in prescribed format with copies of certificates & Mark-sheets, to The Deputy Registrar (Establishment), Sardar Vallabhbhai National Institute of Technology, Surat, Ichchhanath, Dumas Road, Keval Chowk, Surat, Gujarat-395007 so as to reach on or before 20/04/2026 . The envelop should superscribed as Application for the Post of Legal Officer on Purely Contract Basis (Last Date 20/04/2026).	
10.	<u>Selection Process:</u> The shortlisted candidates will be called for interview. The final selection will be based on the performance of candidate during personal interview at SVNIT Surat. Mere fulfilling minimum qualification and experience will not vest any right in candidate for being called for interview. The shortlisting parameters will be decided by the Institute	

	and thereafter, adequate number of candidates, as decided by the Institute, will be shortlisted for interview. The decision of the Institute Authorities shall be final. No correspondence will be entertained in this regard.
11.	<u>General Instructions & Other Information :</u> i. The engagement would be purely on contractual basis. Any claim for absorption at the regular position in the institute will not be entertained at any point of time. ii. The engagement will be subject to their medical fitness. iii. The Institute reserve the right to terminate the services of the appointee at any time by giving one month's notice or payment of one month salary in lieu thereof by either side without assigning any reason. iv. The incumbents shall be eligible for 8 days of casual leave in a calendar year. Any other leave shall not be admissible. v. The appointee will not be entitled for any medical facility/ accommodation or any other type of allowances. vi. The appointees have to attend the office six days a week. vii. In case of exigencies of the work, the appointee shall be required to attend the duty on Holidays. No extra remuneration shall be admissible for the same. viii. The Headquarters of the appointee shall be at Surat. ix. The Institute reserves the right to impose any other reasonable conditions to safeguard the interest of the Institute. x. Any resultant dispute shall be settled within the jurisdiction of Surat. xi. The last date of receiving of application shall be considered as the cut-off date of age, educational qualifications and experience. xii. No TA/DA shall be admissible for appearing in the written test/ Interview/ joining at SVNIT, Surat. xiii. The Institute reserves the right not to fill up the positions, cancel the advertisement in whole or in part without assigning any reason and its decision in the regards shall be final. xiv. The appointment is purely on Contract Basis initially for a period of one year and which may be renewed further upto maximum of one year subject to institute requirement and satisfactory performance of the candidate. The renewal of tenure/ enhancement of monthly remuneration of candidate will be based on performance of the candidate which will be assessed by the Institute level committee.
