The following resolutions were adopted by Academic Performance Review Committee (APRC) held on 20th August 2018 :

Item No. 1 : To consider and adopt suitable resolution in the cases of weak students who have failed in more than three courses (i.e. theory subject, practical, workshop, seminar, project etc) in previous Academic Year 2017-18 (Odd plus Even semesters together).

Reso. No. 1 : Resolved that tentative registration of the students (as per APRC 2018 APPENDIX Reso No.1), who have failed (i.e. who have obtained 'FF', 'NA', 'XX' and 'II' grade) in more than three courses (i.e. theory subject, practical, workshop, seminar, project etc) of odd plus even semesters together at previous academic year 2017-2018 be cancelled for Academic year 2018-19.

Further, resolved that these students be allowed to re-register at appropriate semester **for the failed courses** ('FF', 'NA', 'XX' and 'II' grade courses) and pay necessary fees and re-register and repeat the failed courses during the academic year 2018-19. Their attendance will be counted from the date of registration of failed courses and they may be allowed to appear in makeup test of MIDSEM Examination. The last date of registration of such failed courses will be **August 31, 2018**.

Also, resolved that full tuition fee be refunded to the students as per the list below who have paid the fees for the odd semester of B.Tech./M.Tech./M.Sc. for the Academic Year 2018-19.

Item No. 2 : To make suitable resolution in the cases of weak students having backlog of (n-2)nd year, i.e., 1st year / 2nd year (and 3rd year in case of M.Sc. students) (where n=current year).

Reso. No. 2.1(a) : Following resolutions were adopted in accordance with Academic Regulations 15.5 :

Resolved that students, having more than one backlog course, at 1st or 2nd years [i.e.(n-2)nd years], are prevented from continuing their registration in 3rd and 4th year [i.e. nth years] respectively of their B.Tech Programs during Academic Year 2018-19. They are required to appear in the supplementary examinations (theory & practical) of Odd and Even Semesters to be held during Jan./Feb.2019 and June/July 2019 by filling examination forms during the appropriate semesters and paying the required examination fees.

Resolved further that those students who have been awarded 'XX' grade are required to re-register and repeat the same subject(s) at appropriate semester by paying necessary fees and appear at appropriate semester examination. The last date of registration of such failed courses

will be **August 31, 2018** in current semester. Resolved further that their attendance will be counted from the date of registration of failed courses, and they may be allowed to appear in makeup test of MID SEM Examination.

Also, resolved that full tuition fee be refunded to the students who have paid the fees for the odd semester of B. Tech. for the Academic Year 2018-19.

The student may request for re-registration in a failed course in order to improve his performance.

Reso. No. 2.1(b) : Following resolutions were adopted in accordance with Academic Regulations 15.5 :

Resolved that students, having more than one backlog course, at 1st or 2nd or 3rd years [i.e. (n-2)nd years], are prevented from continuing their registration in 3rd, 4th and 5th years [i.e. nth years] respectively of M.Sc. during Academic Year 2018-19. They are required to appear in the supplementary examinations (theory & practical) Odd and Even semesters to be held during Jan./Feb. 2019 and June/July 2019 by filling examination forms during the appropriate semesters and paying the required examination fees.

Resolved further that those students who have been awarded 'XX' grade are required to re-register and repeat the same subject(s) at appropriate semester and pay necessary fees and appear at appropriate semester examination. The last date of registration of such failed courses will be **August 31, 2018** in current semester. Resolved further that their attendance will be counted from the date of registration of failed courses and they may be allowed to appear in makeup test of MID SEM Examination in current semester.

Also, resolved that full tuition fee be refunded to the students who have paid the fees for the odd semester of M.Sc. for the Academic Year 2018-19.

The student may request for re-registration in a failed course in order to improve his performance.

LIST OF STUDENTS AS PER APRC 2018 APPENDIX RESOLUTION NO. 2.1(b)

Reso. No. 2.2 : Resolved that students of B.Tech and M.Sc. programs with one course backlog at (n-2)nd year (i.e. 1st or 2nd or 3rd year as the case may be) (as per list below) are allowed to register and pay tuition fees for all regular courses in nth year. They are required to appear and clear the (n-2)nd year course in the appropriate supplementary examinations. They will not be allowed to register further in (n+1)th year, till they clears the (n-2)nd year backlog course; and the marksheet of nth year will not be given to them, till they complete the backlog of (n-2)nd year. The last date of registration of such courses will be **August 31, 2018** for current Semester.



Resolved further that their attendance will be counted from the date of registration of failed courses and they may be allowed to appear in makeup test of MID SEM Examination.

Further, it is resolved that contents of aforesaid resolution will be applicable for current academic year only. The APRC committee felt that such concession be stopped with effect from academic year 2019-2020 and Institute Academic Regulations be followed for movement of students from one year to next year.

The student may request for re-registration in a failed course in order to improve his performance.

Item No. : 3 : To discuss and resolve the cases of those students who have failed in three or less than three courses (including theory, practical, workshop, seminar, project, etc.) during the previous year.

Reso. No. 3.1 : Following resolutions were adopted in accordance with relevant Academic regulations Clause 15.4 :

Resolved that the students (as per APRC 2018 APPENDIX Reso No.3.1), who have failed in 3 or less than 3 courses in previous year, are required to appear in appropriate supplementary examinations. The students have to pay necessary examination fees and fill examination forms for appearing in the supplementary examinations (including theory, practical, workshop, seminar, project, etc.) (Odd & Even Semester) to be held during Jan./Feb. 2019 and June/July 2019 for the Academic Year 2018-19.

The student may request for re-registration in a failed course in order to improve his performance.

Reso. No. 3.2 : Resolved further that those students who were awarded 'XX' grade will have to re-register and repeat the same subject(s) at the appropriate semester to undergo complete course work for such courses by paying necessary fees and appear at the appropriate semester examinations.

The last date of registration of such courses will be **August 31, 2018** for current Semester.

Resolved further that their attendance will be counted from the date of registration of failed courses, and they may be allowed to appear in makeup test of MID SEM Examination.

The members also recommended that this will be put for discussion in next Senate. Accordingly the following students who were not able to complete their UG studies in seven years at this Institutes, their registration stands cancelled and their names be removed from the Institute Rolls.


