The written tests/ presentations/ interviews were conducted through offline mode during 1-9 August 2021. In view of the joining of the Director at the Institute, the Board was requested to consider and approve the recommendations of the Selection Committee meetings for the Special Recruitment Drive for the post of Assistant Professor Grade-II held during 1-9 August 2021.

The panel of experts of the selection committee for conducting the interview for the post of Assistant Professor Grade-II, which has not earlier approved by the BoG in the 59th meeting, was placed in the present BoG meeting (60th meeting) for rectification. It was observed by the BoG that the list of panels of experts attached to the note is not signed by the competent authority. There are some procedural lapses noticed by the BoG members in constituting the panel of experts as the same was constituted without the prior approval of BoG and Senate.

After deliberation, it was resolved;

"In view of discrepancies as stated above it was resolved not to open the recommendations of the Selection Committee meetings for the post of Assistant Professor Grade II of various departments held during 1-9 August 2021. The vacant post of faculty position should be re-advertised at the earliest."

Item 60.05: AOB – Annual Maintenance Contract (AMC) for Electrical System (LT) in the SVNIT campus, Surat.

The process of the new tender will take about 2-3 months time for its complete and the existing agency is not willing to extend its services for the work of LT AMC.
