Professor Amit Prashant and Shri Manharbhai Sanspara could not attend the meeting due to preoccupation. At the outset Prof. Anupam Shukla, Director and Chairman BoG warmly welcomed all the members present and thanked them for sparing their valuable time for the meeting. He has briefed the major ongoing activities for campus development including construction works by CPWD under HEFA & EWS, maintenance of buildings by NBCC etc. The steps taken for implementation of New Education Policy of Government of India was also briefed and decision taken by Senate in this regard. He emphasized that to improve the NIRF Ranking of the institute

and to improve public perception immediate repair & maintenance of all old buildings & hostel is essentially required. The CPWD has been advised to submit their proposal for major repair works of all hostel and old academic buildings. Thereafter, following agenda items were deliberated:

- Item 61.01: To note and approve the action taken on the resolutions adopted by the Board of Governors in its 59<sup>th</sup> meeting held on 17-18 August 2021 & 60<sup>th</sup> Special meeting held on 29.07.2022.
- **Reso.61.01:** It was noted that the minutes of 59<sup>th</sup> & 60<sup>th</sup> meetings were approved on 29.07.2022. The action taken on the agenda items were noted. approve the recommendations of the Departmental Promotion Item 61.05: Committee for grant of promotion to the eligible Non-Teaching employees of the Institute (Group B & C)

The Board noted that the Institute has constituted Departmental Promotion Reso.61.05: Committee to assess suitability of the Non Teaching employees of the Institute for promotions. in line with MHRD letter No.F.35-5/2018-TS.III dated 20/02/2019 regarding recommendations of Oversight Committee for removal of anomalies of non-teaching staff and revised Recruitment Rules (RRs). The DPC has assessed the same. Total 20 (Group B & C) employees were found eligible for assessment through DPC. The departmental proficiency test for Group B & C employee was held on 06.09.2022. The recommendations of the DPC are kept in

a sealed envelope. It was clarified that all the procedure as required for DPC were followed. After deliberation, it was agreed to open the envelope for recommendation of Departmental Promotion Committee for grant of promotion to the eligible Non-Teaching employees of the Institute (B & C).

Item 61.06: To consider and approve the revised norms for proper utilization of CPDA by faculty of SVNIT, Surat

Reso.61.06 It was briefed that, the Board of Governors in its 57<sup>th</sup> Meeting held on 26/03/2021 adopted the guidelines accepted by the NITSER Council for proper utilization of CPDA by faculty in NITs issued by Ministry of Education (earlier MHRD) vide letter No.F.No.35-6/2016-TS.III dated 08/06/2017. Accordingly, the norms for utilization of Cumulative Professional Development Allowance (CPDA) were implemented with effect from 1<sup>st</sup> April 2021. With a view to promote more research and development culture in the Institute a committee has been constituted to review the existing norms of the CPDA (approved by the 57th BoG held on 26.03.2021) in line with orders of Ministry of Education issued from time to time. The committee has suggested modification in the existing norms. After deliberations the Board;

"Resolved to approve the modification in the existing guidelines at the institute for utilization of CPDA by the SVNIT faculty members. The updated modified guidelines may be issued by the institute."

Item 61.07: To approve conferment of the Degree & awards to the Bachelor of Technology, Master of Technology, Master of Science (Five years Integrated Programme) and Doctor of Philosophy.

Reso.61.07: The Board was briefed that, the 19<sup>th</sup> Convocation of the Institute is expected to schedule during the Month of October/ November 2022. The exact date of convocation has not been fixed. In terms of NIT Statutes under clause 8 (iii) the Senate in its 55<sup>th</sup> Meeting held on 20.09.2022 recommended the list of 1296 degree recipients and 35+02 medalists/ cash prize winners to the Board of Governors for conferment of the same. The list was circulated to the members through mail and was also placed before the Board. The date for conferment of degree, shall be the date of approval by the Board of Governors for conferment of degree. After deliberation it was;

"Resolved to approve the recommendations of the Senate for conferment of 1296 degrees/medals to the B.Tech (733), M.Tech (376), 5 Years integrated M.Sc. (119) and PhD (68) of 2021-22 batch and 35 medalists & 02 cash prize winners to be conferred during 19<sup>th</sup> Convocation of the Institute".

"Resolved further that, the date of conferment of Degree/ Medal will be the date of BoG resolution, i.e 27.09.2022. The original Degree Certificate(s) may be handed over to the desirous students after 27.09.2022 with the signature of the Institute Authorities".

Item 61.08: To note and approve the Reservation Roster Register for Faculty cadre at SVNIT Surat and to initiate the recruitment drive for all cadre of faculty.

Reso 61.08 The Board was informed that in pursuance of Ministry of Education, Govt. of India directives, issued vide Letter No.F.No.33-3/2018-TS.III dated 05/11/2019 for implementation of the provisions of the Central Educational Institutions (Reservation in Teacher's Cadre) Act 2019, an Institute Level Committee was constituted for recasting of existing Reservation Roster Register for Faculty cadre posts at SVNIT Surat. The Committee prepared the Reservation Roster Register for Faculty Cadre at SVNIT, Surat. As per the register following cadre wise faculty posts (including backlog vacancies) are proposed to be advertised on Direct Recruitment basis:

The Ministry representative present in the meeting advised that before implementing the roster register, the institute ACoFAR should take necessary action for distribution of faculty position across the cadre and departments. Possible recruitment for movement to higher academic grade for the serving faculty members of the respective departments of the institute may be as per provisions of Schedule –E, Note-1 (5). The proposal of ACoFAR for proposed advertisement including category wise distribution of post across the departments be placed before Board for approval. Regarding Expert nominee of the Board and Expert nominee of Senate for the Selection Committee, the Board authorized the Chairman BoG to approve the list of Experts to be member of the Selection Committee for various faculty positions. After deliberation it was;

"Resolved to defer the matter to the next meeting of Board of Governors."

"Further resolved to authorize the Chairman, BoG & Director to finalise the list of Experts as Board Nominee & Senate Nominee in the Selection Committee(s) for recruitment of faculty and non-faculty position in accordance with provisions of NIT Statutes."

- Item 61.09: To note the status of engagement of Shri Ravinder Kumar, Assistant Registrar, SVNIT, Surat at MoE, NITs Division New Delhi on loan/attachment basis.
- Reso.61.09 The Board was briefed that Shri Ravinder Kumar, Assistant Registrar has been posted at Ministry of Education from the date of joining at the institute. His engagement with MHRD/MOE has been extended from time to time. After deliberations,

"Resolved to note the status of engagement of Shri Ravinder Kumar, Assistant Registrar, SVNIT, Surat at MoE, NITs Division New Delhi on loan/attachment basis which is extended till 09.09.2023."

- Item 61.10: To ratify the action taken by the Director for extension of probation of Dr. L. K. Saini, Assistant Professor, Department of Physics.
- Reso 61.10 The Board was informed that, Dr. L. K. Saini joined to the post of Assistant Professor (AGP-8000) on 28/01/2019. His probation was initially for a period of one year which was extended for a period of one year w.e.f. 28/01/2020 as per resolution adopted by the Board in its 53rd meeting held on 14/03/2020. His probation was further extended for a period of one year w.e.f. 28/01/2021 While approving the extension for probation it was also resolved by the 57<sup>th</sup> BOG Meeting that, the performance assessment of Dr. L. K. Saini be reviewed during the extended probation period and be placed before the Board for his confirmation. The matter was placed in the 58<sup>th</sup> Meeting of BOG wherein it was decided to review the same after receipt of the vigilance clearance from the CVO and 2nd stage advice from CVC. The Institute received the advice of CVC vide Letter No.F.No.C-13011/73/2019-Vig. Dated 25/10/2021.

Further, the copy of Inquiry report, tentative views of the Board of Governors of SVNIT, Surat alogwith advise of CVC was forwarded to Dr. L. K. Saini on 22/11/2021 and Dr. L. K. Saini has submitted his reply vide letter dated 20/12/2021. His extended probation period has been completed on 27/01/2022.

The committee was constituted vide No. E/141/Confirmation/303 dated 18/06/2021 was requested to review the performance assessment of Dr. Saini. The Committee assessed the performance of Dr L K Saini. On the recommendation of the committee, the probation of Dr. L. K. Saini, Asst. Professor, Department of Physics was extended further for one year w.e.f. 28/01/2022 or till further orders. The Board took note of the same. After deliberation it was;

"Resolved to ratify the action taken by the Director for extension of probation of Dr. L. K. Saini, Assistant Professor, Department of Physics for one year w.e.f. 28.01.2022."

## Item 61.11: To consider the representation/ reply submitted by Dr. L. K. Saini Assistant Professor, Department of Physics to take appropriate action

Reso 61.11 The Board was informed that the Board of Governors in its 49<sup>th</sup> Meeting held on 15/06/2019 resolved to initiate Regular Departmental Action (RDA) as per CCS (CCA) Rules against Dr L K Saini, Assistant Professor and authorized the Director to issue charge sheet as per CCS (CCA) rules. Accordingly, the inquiry against Dr. L. K. Saini was initiated and Dr. L. K. Saini was suspended vide Order No.E/LKS/636 dated 08/07/2019. His case was referred to the Central Vigilance Commission for their first stage advice. However, the Chief Vigilance Commission replied to submit the case through CVO, MHRD. Accordingly, the Institute has sent a letter to CVO, MHRD for first stage advice vide letter dated 06/09/2019 and CVO, MHRD advised to go for second stage advice in the matter vide letter dated 05/12/2019.

The charge-sheet was issued vide Memorandum dated 26<sup>th</sup> September 2019 against which Dr L K Saini morally accepted all Articles of the Charges vide letter dated 03/10/2019. The Institute appointed the Inquiry Officer (I.O) and Presenting Officer (P.O) and the preliminary hearing was held on 18/10/2019 and

on the same day the Charged officer accepted all the article of charges against him and inquiry was concluded.

After completion of inquiry his suspension was revoked on 15/11/2019. The Report of Inquiry Officer was placed before Board of Governors in its 53<sup>rd</sup> Meeting held on 14/03/2020 and resolved to forward the same to Chief Vigilance Commission, New Delhi through CVO of the institute for second stage advice. The matter was sent to CVO, Ministry of Education, New Delhi for 2<sup>nd</sup> stage advice and in response, the Vigilance Section advised the Institute to furnish tentative views of the Disciplinary Authority and CVO of the Institute. The matter was placed before the 57<sup>th</sup> Meeting of Board of Governors held on 26/03/2021 to provide tentative views and the Board decided its tentative views on the matter which was forwarded to CVO, Ministry of Education on 16.4.2021. The Vigilance Section, MoE, replied the same vide Letter on 25/10/2021. The copy of Inquiry report, tentative views of the Board of Governors of SVNIT alogwith advise of CVC was forwarded to Dr. L. K. Saini on 22/11/2021 and he has submitted his response on 20/12/2021. After deliberations, it was:

"Resolved to defer the matter for next Board Meeting and will be discussed again. The institute may provide the additional information, if any as desired by the Members of the Board."

- Item 61.12: To note the status of recruitment process for non-teaching Group B & C posts including relaxation of upper age limit upto 56 years to the persons who are working/serving at SVNIT, Surat on the date of advertisement (for Group B & C posts) on ad-hoc/ temporary/ contractual/ outsourced basis and daily wages basis having continuous one-year of service at SVNIT, Surat.
- Reso 61.12: The Board was briefed that, the Institute has advertised vacant posts of Group B & C during the Year 2021. The total No. of posts advertised is 111 and against which 7292 applications have been received. The Scrutiny Committee for scrutiny of the application received were constituted. It was informed that, the Board of Governors of SVNIT in its 52<sup>nd</sup> Meeting held on 09/01/2020 resolved that Institute can go ahead for the recruitment process of non-teaching staff as per new Recruitment Rules of NITs and given age relaxation upto 56 years to those who are working on adhoc/temporary/contractual/outsource basis in the Institute

to participate in the first regular recruitment process for the post for which they fulfil all other conditions mentioned in the Recruitment Rules proposed by the Oversight Committee as per MHRD Letter No.F.35-5/2018-TS.III, dated 20th February, 2019.

Therefore, the advertisement notifications for recruitment of various Group B & C posts were published by the Institute during the Month of March, 2021 and one-time age relaxation in upper age limit upto age of 56 years has been given to the persons currently engaged at SVNIT, Surat on Ad-hoc /Temporary / Contractual / Outsourced basis, to participate in this regular recruitment process for the posts for which they fulfil all other conditions including educational qualifications mentioned in the Recruitment Rules (2019),

Against the advertisements for recruitment of various Group B & C posts, the Institute's daily wagers, persons engaged through out-sourced agencies, workmen engaged through various service providers have applied to the various posts and claimed for age relaxation against the above recruitment notification. The workman engaged through ad-hoc/ temporary/ contractual/ outsourced basis and daily wage basis having continuous one-year service at SVNIT, Surat have been extended the benefits of relaxations of upper age limit upto 56 years to all those applicants who were working at SVNIT, Surat on the date of advertisement. After deliberation it was

"Resolved cancellation of the earlier advertisement (2021) and to re-advertise the non-teaching position for which recruitment process has not been completed. The applicant already applied earlier against the advertisement post in 2021 may be allowed to apply afresh with the exemption for payment of application fees, if any quoting their reference number of earlier application."

"Further resolved to approve the one-time age relaxation in the first regular recruitment process for non-teaching posts upto upper age limit of 56 years to the persons who are working/serving at SVNIT, Surat on the date of advertisement to the workmen engaged on ad-hoc/ temporary/ contractual/ outsourced basis engaged through various service provider and institute daily wages basis having one-year of service at SVNIT, Surat."

- Item 61.13: To consider and approve the modalities for assessment of applications received for appointment on compassionate ground at SVNIT, Surat
- Reso 61.13 The Board was briefed that, the advertisement for the vacant posts for nonteaching Group A, B & C were published during the Month of March 2021, wherein two posts of Senior Assistant/Junior Assistant/ Office Attendant and Two posts of Technician/ Senior Technician were earmarked for appointment on compassionate ground as per norms of DoPT, Government of India. The Institute received total 08 applications for appointment on Compassionate ground from 09 dependents of deceased employees of the Institute. A Committee Chaired by Deputy Director was constituted vide Surat vide order dated June 26, 2021to frame the guidelines for point based merit system for assessing the merit of the claims of compassionate in line with DoPT/Govt. of India norms/earlier decisions/ resolutions adopted by the BoG. The Committee consulted the guidelines on the said appointments devised by CBIC and recommended that the Table of allocation of points to various attributes based on a 100-point scale as per Letter No. A.12012/52/2018-Ad.III.B dated 15<sup>th</sup> May, 2019 CBIC of Department of Revenue, Ministry of finance may be adopted for assessing comparative merit of the applicants for compassionate appointment. After deliberation it was;

"Resolved to approve the modalities for assessment of applications received for appointment on compassionate ground for recruitment of B & C Post at SVNIT, Surat."

- Item 61.14: To consider and approve the Intellectual Property Rights Manual Guidelines, Policy& Forms for SVNIT, Surat
- Reso 61.14: The Board was briefed that, the Finance Committee & Board of Governors in its meeting held on 05/12/2012 approved the norms of Intellectual Property Rights vide Resolution no.5. The Institute is in process of establishment of IPR Cell in the Institute as per the directives from the Government to encourage and support the researchers of the Institute within emphasizing importance of IPR rights, encouragement on IP generation & its utilization, creating educational materials for IP, inculcate & appreciate value of IP formation etc. A committee was constituted for revision of existing IPR policy of the Institute. The Committee prepared the Intellectual Property Rights Manual Guidelines, Policy& Forms

which has been vetted by the patent consultants appointed by the Institute. After deliberation it was;

- Item: 61.17.1 To consider and approve the recommendations of the 55<sup>th</sup> meeting of Senate held on 20.09.2022 regarding de-merger of Department of Mathematics & Humanities to Department of Mathematics, Department of Humanities & Social Sciences and Department of Management Studies.

It was informed to the Board that the Senate in its 55<sup>th</sup> Meeting held on 20.09.2022 recommended to demerge the existing 'Department of Mathematics and Humanities' into three Academic Departments, i.e. Department of Mathematics, Department of Humanities and Social Sciences and Department of Management Studies. The existing Mathematics & Humanities Department consists of faculty from Mathematics, Humanities and Management, which needs to be separated for growth of the Departments and the Institute.

The Department of Mathematics will offer 5-year *Dual Degree Programme in Mathematics and Computing (Bachelor of Technology and Master of Technology)* with 'the exit option after meeting the total credit requirement for the award of the degree of B.Tech. in Mathematics and Computing'. The Dual Degree Programme in Mathematics and Computing (M&C) is primarily intended to produce post-graduate Students with strong foundations to apply their leaning to solve the complex and the interconnected problems of the Industry, Society and to impart better services to the Nation.

It is planned that the Department of Management Studies will offer a two/ five years MBA programme/ Integrated MBA Programme.

The Department of Humanities and Social Sciences will offer courses related to Humanities and Social Sciences for undergraduate and post graduate programme of different departments and will also offer new PG/ Ph.D programme in future.

Upon in-principle approval from the Board, for demerger of department and introduction of new academic programmes, action for Demerger of Departments, designing the course curriculum, number of students including faculty requirements and infrastructure/space/fund requirement will be finalized in due course, which will be placed through Institute Level Academic Advisory Committee/ Senate.

The Board was requested to approve the recommendations of the Senate regarding de-merger of Department of Mathematics & Humanities to Department of Mathematics, Department of Humanities & Social Sciences and Department of Management Studies and in-principle approval for introduction of new academic programmes. After deliberations,

# Item: 61.17.2 To consider and approve the recommendations of the 55<sup>th</sup> meeting of Senate regarding introduction of a 'New Academic Department', i.e. Department of Artificial Intelligence.

It was informed to the Board that the Senate in its 55<sup>th</sup> Meeting held on 20.09.2022 recommended to introduce a new Academic Department, i.e. Department of Artificial Intelligence. The proposed establishment of Department of Artificial Intelligence is aimed to help the students to develop greater understanding and to train towards the formidability and solvability of problems arising from Technology and Societal perspectives. Considering the industry need and placement scenario, it is proposed that the new department will offer undergraduate and post graduate programmes in the field of Computing & Artificial Intelligence.

Upon approval from the Board of Governors of the Institute for establishment of Department of Artificial Intelligence, action will be initiated for course design, course curriculum, number of students, faculty requirements and infrastructure/space/ fund requirement, which will be placed in due course through Senate & Finance Committee. After deliberations,

"Resolved to approve the introduction of new department 'Department of Artificial Intelligence' at the Institute. Detailed proposal alongwith action plan for new department, academic programmes, course curriculum, number of students' intake, faculty requirements and infrastructure/space/fund requirement be placed after recommendation from Senate & Finance Committee of the institute".

Item: 61.17.3 To note the status of engagement of Shri Ajay Kumar Agarwal as Advisor (Civil works) and Shri A. K. Jain as Adviser (Electric works) on contract basis on purely contract basis @ consolidated remuneration of Rs 1 Lakh per month.

It was informed that the Institute has engaged Advisor on contract basis for Civil works and Electric works at consolidated remuneration of Rs 1.00 Lakh per month (on an average of 6-7 days' visits/online consultations per month).

Shri Ajay Kumar Agarwal Additional Director General (Retd), CPWD has been engaged as Advisor (Civil Works) on Contract since 06.01.2020 for a period of one year and the same has been extended on year to year basis. The present extension is till January 2023 or upto completion of new construction works of SVNIT Surat.

Similarly, Shri A. K. Jain, Special Director General (Rtd.), CPWD has been engaged as Advisor (Electrical Works) on Contract since 01.02.2020 for a period of one year and the same has been extended on year to year basis. The present extension is till January/February 2023 or upto completion of new projects of SVNIT Surat.

As per the terms and conditions of their engagement they are being paid honorarium of Rs 1.00 Lakh per month (on an average of 6-7 days' visits/online consultations per month), alongwith Transportation (Institute to provide transport or reimbursement of travel expenditure and other incidental charges on actual basis) & Accommodation (A rent free accommodation and local hospitality will be provided in the Institute's Guest House) for their visit at SVNIT, Surat for the said work.

The Ministry representative present in the meeting observed that such appointment should be made against the regular vacant positions and the incumbent should not be above the age of prescribed age limit as per of GoI orders as issued by the Ministry of Finance Department of Expenditure vide OM No F.No.3-25/2020-E.IIIA dated 9.12.2020. After deliberations, the Board decided to discontinue their engagement after completion of existing contract period as Advisor on consolidated monthly remuneration. However, considering the need of the situation, the institute may take their services as 'Expert' in

various meetings for ongoing construction works and pay honorarium of Rs. 10000/- per meeting day alongwith admissible TA/DA as per rules.

"Resolved to discontinue further engagement of Shri A K Jain and Shri Ajay Kumar Agarwal as Advisor on completion of existing contract period. The institute may take services of Expert in various meetings for ongoing construction/ consultation/ review of ongoing construction activities in the institute and pay honorarium of Rs. 10000/- per meeting day alongwith admissible TA/DA & local hospitality."

"Further resolved to engage third party inspection for the ongoing construction activities being undertaken through CPWD. The third party inspection should be done from other agencies/organisation."
