Item 70.06: To note the status of recruitment of faculty positions

Reso 70.06: It was informed to the Board that, the advertisement for the post of Associate Professor and Professor was issued vide Advt. No. E/ Advt./Asso. Prof./212 and Advt. No. E/ Advt./ Prof./213 on 17.04.2023. The screening of application is under process. The institute is planning to conduct interviews for the post of Associate Professor and Professor shortly. The Board was briefed about pending court case SCA 2752 of 2018 filed by few serving faculty members in the Hon'ble High Court of Gujarat during earlier recruitment process. The Board also took note about the Judgement of High Court of Haryana and Punjab in similar cases. After deliberations,

"The Board of Governors noted the status of various court cases happened at different NITs including SVNIT, Surat during the year 2019 for the faculty positions related to one time relaxations to the Recruitment Rules for the existing faculty members of the Institute at Associate Professor and Professor level.

The Board decided to continue the recruitment process for the advertised post of Associate Professor vide notification no. E/Advt./Asso. Prof./212 and Professor vide notification no. E/Advt./Prof./213 dated 17.04.2023 and advised the Director to complete the ongoing recruitment process on priority."

Item 70.07: To approve the recommendations of the Committee for grant of appointment on Compassionate Ground.

Reso 70.07: It was informed to the Board that, the recommendation of the committee constituted for compassionate appointment was placed before the 67th BoG meeting held on 20.07.2023 wherein it was resolved to refer back the matter to the same Committee to revisit the cases of compassionate appointment. The committee submitted its recommendations with balance and objective assessment. The Board was of the view that as per NIT Act 2007, All appointment made on the non-academic staff of group 'C' Post should be made by the Director of the Institute. As the appointment on Compassionate Ground is for Group C entry level post only, the Director may approve the recommendation and issue appointment offers to the eligible candidates on Compassionate ground which may be reported to the next Board meeting. After deliberation it was;

Reso 70.08: It was informed to the Board that, the Sardar Vallabhbhai National Institute of Technology Alumni Association (SVNIT Alumni Association) has offered to construct for construction of Swimming Pool and Food Court at the institute campus and submitted a draft MoU. The Board welcome the proposal from the SVNIT Alumni Association. While going through the draft MoU for construction of swimming pool and Food Court, the Board suggested that fund for Maintenance of both the projects for a minimum period of 3 years should be included in the proposal and borne by the Alumni Association. The Total fund raising for construction of both the projects will be done by Alumni Association and after construction of Both the projects it will be handed over to the Institute. The loction for construction of both the projects will be decided by the Institute authorities as per the approved Layout Plan. After deliberation, it was

"Resolved to approve the draft MoU between SVNIT Surat and SVNIT Alumni Association for construction of swimming pool and construction of Food Court after incorporating the above observations of the Board."

Item 70.09: To approve conferment of the Degree & awards to the Bachelor of Technology, Master of Technology, Master of Science (Five years Integrated Programme) and Doctor of Philosophy.

Reso 70.09: The Board was briefed that, the 20th Convocation of the Institute is expected to schedule shortly. The exact date of convocation is yet to be decided. In terms of NIT Statutes under clause 8 (iii) the Senate in its 59th Meeting recommended the list of 1434 degree recipients and 29 medalists/ cash prize winners to the Board of Governors for conferment of the same. The list was circulated to the members through mail and was also placed before the Board. The date for conferment of degree, shall be the date of approval by the Board of Governors for conferment of degree. After deliberation it was;
