The Admission procedure, course curriculum, method of fees collection, admission test/ interview, examination, attendance, degree awarding, resource sharing and distribution of income generated, role of service provider (M/s. Intellipaat) and SVNIT Surat etc. be discussed, finalised and recommended by the Senate and be placed again before FC/BoG to proceed further."

Item 73.09 To Consider amendment in the statutes regarding extension of tenure of Chairman, Board of Governors to prevent overlap in functioning of Director and Chairperson.

Reso.73.09: It was informed that, at present, there are no provisions under the Statutes to extend the term of incumbent Chairperson, BoGs or assign the temporary or additional charge of the post of Chairperson, BoGs to the Chairperson, BoGs of any other NITs or CFTIs in the event of occurrence of any vacancy in the office of Chairperson for any reason. As per the instructions received from the President's Secretariat, the institute is required to initiate amendment to insert the following clause in Statutes 14 of Statutes of NITs and IIEST, Shibpur:

(v) "In the event of the occurrence of any vacancy in the office of the Chairperson of Board of Governors by reason of expiry of his or her tenure, death, resignation or otherwise or in the event of the Chairperson being unable to discharge his or her functions owing to absence, illness or any other cause, the Chairperson of an Institute of National Importance (INI) nominated by the Visitor to fill up the casual vacancy, may discharge the functions assigned to the Chairperson under Section 16 of the Act, for a period of six months or till the nomination of a regular Chairperson, whichever is earlier.

Additionally, in case of expiry of tenure, the Visitor may extend the term of the incumbent Chairperson for a period of six months or till the nomination of a regular Chairperson, whichever is earlier."

As the relevant provisions in the Statutes are being inserted under clause (v) of Statute 14 of the Statutes in order to have clear distinctions between the responsibilities of Director and Chairperson and to prevent any overlap of functions provided in the Statutes, it is, therefore, necessary to delete clause (15) of Statute 17 of the Statutes of NITs and IIEST-Shibpur, which exist as under:-

73rd BOG MINUTES dated 22.05.2024

"In the event of the occurrence of any vacancy in the office of the Chairperson by reason of his death, resignation, or otherwise or in the event of the Chairperson being unable to discharge his functions owing to absence, illness or any other cause, the Director may discharge the functions assigned to the Chairperson under Section 16 of the Act".

The Board, in accordance with provisions under Section 26 (2) of the NITSER Act, 2007, resolved to recommend the amendment in the Statutes of NITs and forward the resolution to the Ministry of Education for placing the amendments before the Hon'ble Visitor for consideration and approval, as required under Section 26 (3) & (4) of the NITSER Act, 2007.
