In terms of NIT Statutes under clause 8 (iii) the Senate in its 62nd Meeting recommended the list of degree recipients and medalists/ cash prize winners to the Board of Governors for conferment of the same. It was also informed that, total degrees are 1329. The date for conferment of degree, shall be the date of approval by the Board of Governors for conferment of degree. After deliberation it was:

"Resolved to approve the recommendations of the Senate for conferment of 1329 degrees to the B.Tech (817), M.Tech (266), 5 Years integrated M.Sc. (157) and PhD (89) of 2023-24 batch alongwith medals & Cash Prize winners to be conferred during 21st Convocation of the Institute."

As per aforesaid letter dtd. 06.06.2024, the Institute is required to submit the following details to Ministry of Housing and Urban Affairs (AMRUT Division). The 62nd Meeting of Senate held on 06.08.2024 has recommended to the

The above centre will be fully funded from the grant of the AMRUT 2.0 and grant of Rs.5.00 Crore per year will be sanctioned by the MoHUA, AMRUT Division for initial 2 years. No financial assistance is required from the Institute for establishment of above centre. After deliberation it was;

"Resolved to approve the proposal for Establishment of 'AMRUT Funded Centres of Urban Planning for Capacity Building' by the Ministry of Housing and Urban Development, Government of India for developing capacities in urban planning and to deliver certified training in these areas. The Centre will be funded by the MoHUA, AMRUT Division."

"Resolved further that for establishment of 'AMRUT Funded Centres of Urban Planning for Capacity Building' one of the Senior faculty from Department of Civil Engineering may be appointed as Centre In-Charge."

Item 74.08: To consider and approve the proposal for Establishment of Centre for Tribal Technology Development.

Reso 74.08: It was informed to the Board that, the 62nd Senate meeting held on 06.08.2024 recommended the proposal of Department of Humanities and Social Sciences for Establishment of Centre for Tribal Technology Development at SVNIT Surat to support Tribal welfare. It will reflect SVNIT's acknowledgment of its socio-academic responsibility towards the surrounding tribal communities, who often face marginalization and limited opportunities. It will also align with the institute's mission to use its academic and technical resources for the betterment of society. It draws inspiration from the successful models of community development and technology integration implemented by other Institutes of National Importance, which have demonstrated significant positive impacts on rural and tribal populations. The proposed Centre will run with the existing resources and project funding from external agencies. After deliberation it was;

"Resolved to approve the proposal for Establishment of Centre for Tribal Technology Development at SVNIT, Surat."

- Reso.74.11.1: It was informed that, The Ministry of Education (earlier MHRD), Govt. of India vide letter F No. 35-3/2018-TS.III dated 2nd January, 2019, directed to all the NITs and IIEST, Shibpur for External Peer Review, wherein it has been mentioned that, as per the recommendations of the KaKodkar Committee and accepted by the Council in its 7th meeting dated October 18, 20213, there has to be external review of NITs and IIEST, Shibpur. It has also been mentioned in the aforesaid letter that, a minor review once in 3 years and a

comprehensive review once in 6 years respectively to be carried out with all the Institutes. the approved composition of the committee is comprised of two reputed persons from the academia, two experts from the industry, one eminent citizen and one NIT Alumni. The Committee will be set up by the BoGs of NITs/ IIEST with the approval of the Standing Committee of Council and the term of the committee members would be 9 years with a 3rd of its members retiring every 3 years. It was proposed that till completion of External Peer Review by the constituted committee, the institute may carry out the academic audit for all UG and PG programmes of various departments through a committee to be constituted by the Chairman BoG.

After deliberation it was;

"Resolved to empower the Chairman, Board of Governors to approve the names of members for External Peer Review committee comprise of two reputed persons from the academia, two experts from the industry, one eminent citizen and one NIT Alumni. The proposed names may be forwarded to the Ministry of Education for obtaining the approval of the Standing Committee of the NIT Council."

The Chairman BoG is empowered to approve the constitution of committees for Academic Audit of various programmes offered by the different departments. The report of the committee shall be placed before Senate/ Board for consideration of the same."
