Reso 75.07: It was informed that, the existing sanctioned strength for the faculty is 296 and the distribution of faculty in various cadres (Professor: Associate Professor: Assistant Professor) is in the ratio is 1: 1.2: 2.15 (as per 72-BoG Meeting dated 15.02.2024). In view of opening of new departments and requirement of the institute, the flexibility in the cadre strength at each levels of faculty cadre is required. The vacancies for the post of Professor & Associate Professors in all the respective departments are not adequate, hence it is required for re-distribution and re-casting of roster for faculty cadres. A committee was constituted to update the Cadre Wise Reservation Roster for Faculty as per Central Educational Institutions (Reservation in Teacher's Cadre) Act, 2019 and instructions issued by Ministry of Education, Govt. of India. The ongoing recruitment notices were amended after obtaining the approval of the Hon'ble Chairman BoG's for the Reservation Roster Register of the faculty cadre posts and following vacancies as on 30th September, 2024.
