Minutes for the *Eighteenth* meeting of the *Board of Governors* for the Sardar Vallabhbhai National Institute of Technology, Surat held on Saturday, the 28th February, 2009 at 1.30 p.m. in the Conference Room of the Hotel Airlink, 75 Off Nehru Road, Near Santacruz Airport, Vile Parle (E), Mumbai-400 099.

At the outset, the Chairman, Board of Governors warmly welcomed members of the Board of Governors.

The following business was transacted:

- Item 1: To confirm the minutes of the 17th meeting of the Board of Governors held on 17/01/2009.
- Reso. 1: "Resolved that the minutes of the 17th meeting of the Board of Governors held on 17/01/2009 be confirmed."
- Item.2: To note and approve the action taken on the resolutions adopted by the Board of Governors at its 17th meeting held on 17/01/2009.
- Reso. 2: "Resolved that the action taken on the resolution(s) adopted by the Board of Governors at its 17th meeting held on 17/01/2009 be noted and approved."
- Item 3: To ratify the action taken by the Chairman, BOG's (to be nominated by the BOG's and Chairman, Senate (an expert nominee of the senate) nominating two experts (BOG nominee) and one expert (Senate nominee) by the Chairman, Board of Governors and Chairman Senate on the Selection Committee for direct recruitment of various vacant faculty positions.
- Reso. 3: "Resolved to ratify the action taken by the Chairman, BOG's (to be nominated by the BOG's and Chairman, Senate (an expert nominee of the senate) nominating two experts (BOG nominee) and one expert (Senate nominee) by the Chairman, Board of Governors and Chairman Senate on the Selection Committee for direct recruitment of various vacant faculty positions (APPENDIX: 3.1)."

Item 4: To consider the recommendations of the Selection Committee meetings held from 14/2/2009 to 26/2/2009 for recruitment to the posts of Lecturers, Assistant Professors & Professors in various departments of the Institute.

Reso. 4: The Director of the institute apprised the members of the Board of Governors that the overall performance of the candidates appeared before the Selection Committee were remarkable and especially candidates belonging to the reserved category were also competent keeping in view the non availability of competent candidates for direct recruitment to the post of Lecturers.

"Resolved to accept the minutes/recommendations of the Selection Committee meetings held from 15/2/2009 to 26/2/2009 for direct recruitment to the posts of Lecturers, Assistant Professors & Professors in various departments of the Institute."

"Resolved, further that the new Pension Scheme in SVNIT – accounting procedures & Introduction of New Pension Scheme be introduced for new entrants as per MHRD O.M. No. F.20-46/2003-TS.III dtd: 09/06/2004".

"Further, resolved that all new recruitees (except internal candidates) shall be covered under a new pension scheme based on defined contributions. The existing pension scheme in SVNIT will not be applicable to newly recruited employees".

"Resolved, further that the method of calculation of qualifying service(s) / pension and other retirement benefits for the above category shall be made in accordance with the instructions contained in the Central Civil Services [CCS] (Pension) Rule 1972 for employees on submission of technical resignation on or after 1/1/2004 by employees governed by CCS (Pension) Rules 1972 as amended from time to time."

"Resolved, further that the MHRD O.M. bearing No. F.20-46/2003-TS-III dtd: 16 June, 2004 be implemented for the new entrants and suitable accommodation be provided if available. However, in case the institute is unable to provide suitable accommodation of their entitlement in the campus; they will have to furnish a certificate in prescribed format for drawal of HRA till allotment of suitable accommodation to them."

"Resolved, further that other allowances like; Group Insurance Scheme, LTC, Leave etc. shall be admissible as per Institute rules applicable to new entrants amended from time to time as per MHRD / Board of Governors guidelines."

"Resolved, further that Medical reimbursement facility shall be applicable to new entrants as per rules of the institute. However, upon their retirement on attaining, the age of superannuation, Medical reimbursement will be as per MHRD / Board directives."

"Further, resolved to protect the basic pay as per GOI rules to the new recruitees who are in service with Govt. of India or centrally funded university on Central / States grant in aid institutes except private / self finance institutes."

"Resolved, further that new entrants be appointed subject to future clearance of Police Verification of character and antecedents (except internal candidates)."

"Resolved to issue an offer of appointment for the post of Professor(s), Assistant Professor(s) and Lecturer(s) in the various departments as post-wise and department-wise listed below with the conditions recommended by the Selection Committees (APPENDIX: 4.1 to 4.29)."

"Further, resolved that consequent upon selection of internal faculty members for direct recruitment to the post(s) of Assistant Professor(s) or Professor(s) in respective department, if any, the wait listed candidate(s) if any, recommended by the Selection Committee be appointed against their post for smooth running of academic schedule."
