In this connection, it will be appropriate to mention here that; the MOU was signed between M/s. National Building Construction Corporation Limited. New Delhi and SVNIT, Surat for the Construction of civil work i.e. Class Room Complex, Academic Department Building (Applied Mathematics & Humanities Department and Applied Physics and Chemistry Department), Extension of Academic Buildings and Construction of Residential Quarters at SVNIT, Surat in second phase vide Reso: 8 of 44th meeting of Building & Works Committee held on 12/12/2011 duly approved in 27th Meeting of Board held on 06/05/2012.

Accordingly, M/s NBCC was informed about administrative approval and was advised to initiate further action for inviting tenders. M/s. NBCC Ltd, New Delhi had invited the e-tenders from their prequalified eligible contractors for construction of Physics, Chemistry & Maths. & Management Department Building and Extension of Electronics, Electrical & Chemical Engineering Department at SVNIT, Surat. The received tenders were opened on 26/12/2012 at 3:30 p.m. and on verification of tender documents the price bid were opened on 07/01/2013. In both the meetings, authorized members of e-tender committee (NBCC) and the representatives from the SVNIT, Surat were remained present at the Zonal Office of National Building Construction Corporation Ltd., Mumbai.

On scrutiny of the price bid by the above committee (NBCC & SVNIT), it has been recommended;

(1) For construction of Civil Works i.e. Construction of Academic Block for Applied Physics, Applied Chemistry & Applied Maths. & Humanities Department Building, total three (03) tenders were received. The Committee (SVNIT, NBCC/B&WC) has recommended to approve the award of the Civil Works i.e. Construction of Academic Block for Applied Physics, Applied Chemistry & Applied Maths. & Humanities Department Building at SVNIT, Surat to M/s. Classic Engineers of New Delhi at 3.69% below the estimated cost of Rs.28,59,37,444.00 (i.e. Rs.27,53,86,352.32) being the lowest tenderer.

(2) For extension of Electronics, Electrical & Chemical Engineering Department total three (03) tenders were received. The Committee (SVNIT,NBCC and B&WC) has recommended to approve the award of Civil for extension of Electronics, Electrical & Chemical Engineering Department at SVNIT, Surat to M/s. R. N. Dobaria of Surat at 3.80% above the estimated cost of Rs.51,98,79,728/- (i.e. Rs.53,96,35,157.66) being a lowest tenderer. And same has been also recommended for financial approval of the Board by the Building & Works Committee in its 51st Meeting held on 06/02/2013.
