This result in saving of concrete quantity and reinforcement steel.

However after carrying out Geo Technical Investigation and testing as also after sharing the experience of other construction works carried out at SVNIT, the detail structural design were finalized (after award) which shows the raft thickness of 45 cm suffice the purpose. This result in saving of concrete quantity and reinforcement steel.
