At the outset, the Chairman welcomed the Members of B&WC and thanked them for sparing their time for the special meeting in short notice. Prof. Rajesh Tripathi, Dean (P&D) & Head Civil Engg Deptt, NIT Raipur has attended the meeting as special invitee. Thereafter, following agenda item was taken up for discussion with following resolutions:

Item: 76.01 To consider and approve Preliminary Estimate submitted by CPWD for the work of "Laying of new Sewer Line and Manholes behind Sarabhai Bhavan Hostel Building in SVNIT Campus, Surat".

Reso.76.01: The Committee was briefed that, the campus is grouped into academic, hostel and residential zones and the existing drainage line network of these buildings are very old and was laid more than 30 years back which is not sufficient to carry the drainage load of various buildings in the campus. At present, the drainage line behind Sarabhai Bhavan Hostel Building in SVNIT Campus is damaged due to settlement resulting into the overflow of the sewer at many places in the vicinity of

the hostels and the residential areas which spread to the surrounding of the hostel/academic/residential buildings. This further creates serious unhygienic conditions in the vicinity of the buildings. In view of the above and looking to the future expansion of the infrastructure buildings viz. Administrative Building, Lecture Hall Complexes and Type – III quarters in the campus, there is an urgent need for the upgradation of existing drainage line/laying to be replace with a new drainage line behind Sarabhai Bhavan Hostel Building in SVNIT Campus, Surat so as to accommodate additional load to the existing line. Therefore the Institute had requested the CPWD to prepare Preliminary-cum-Detailed Estimate for the same. The CPWD has submitted preliminary estimate of Rs.24,37,667/including 5% contingencies and 11.90% EPF & ESI Charges for laying of new Sewer Line and Manholes behind Sarabhai Bhavan Hostel Building in SVNIT letter No.23(27)/EE/SURAT/2022-23/949, Dt.09/02/2023. Looking to the situation, the members observed that this is an essential work to be carried out on emergency basis through CPWD. The work may be taken up with the ongoing construction work. It was informed that the work may be completed within one-month time period. After careful consideration of all the relevant aspects, following resolution was adopted;

"Resolved to recommend to approve Preliminary Estimate submitted by CPWD for the emergent work of Laying of new bypass Sewer Line and Manholes behind Sarabhai Bhavan Hostel Building in SVNIT Campus, Surat at the estimated cost of Rs. 24,37,667/- (Rupees Twelve Four Lacs Thirty Seven thousand Six hundred and Sixty Seven only) including 5.0% Contingencies charges and 11.90% EPF and ESI. This will be part of ongoing construction work of Type III quarters which is already in progress by CPWD. The items which are not covered in the existing tender may be charged as per standard procedure of CPWD."

"Further resolved to complete the work within one-month time period."

"Resolved further that the action taken on the above resolution be placed in ensuing meeting of Building & Works Committee."
