Item: 80.03: To consider and note on going repair work carrying out by NBCC for the various building constructed by NBCC during 2008-2016.

Reso.80.03: It was informed to the Committee that the Chairman cum Managing Director, NBCC has been repeatedly informed about the pending complaints regarding defects in various civil works carried out by NBCC. The NBCC has taken up the repair work only in the building of Physics, Chemistry and Mathematics, which is progressing at a very slow pace resulting into huge inconvenience to the Institute in performing academic activities. The representative of NBCC was also present through online in the meeting. The Ministry Representatives present in the meeting expressed their displeasure on the slow process of repair works in the Department of Mathematics, Physics and Chemistry. The Representative of NBCC assured to speed up the repair work for these departments and ensured that the work of Department of Mathematics will be completed by 30th June 2024 and for Department of Physics it will be completed by 31st July 2024 and the work of Department of Chemistry will be completed by 30th September 2024 positively. Regarding, New CRC Building, the B&WC was informed that a five members committee has been formed by the Board of Governors, SVNIT for carrying out the independent structural health assessment of the New Class Room Complex (New CRC) building constructed by NBCC at SVNIT, Surat and the final recommendation/report of which is awaited. The NBCC Official informed that the concerned Contractor has been blacklisted by NBCC who had carried out the work of New CRC Building. The copy of said order will be shared with the institute and the Ministry of Education. The Committee asked representative of NBCC to expedite decision and further action on the long pending issue of severe defects in the New CRC building by addressing the important issues of (i) Cost of rehabilitation or demolition and new construction to be borne by NBCC (ii) certification of years of safe serviceable life post rehabilitation work, if

rehabilitation is decided etc. On detailed deliberations, it was:

"Resolved to request NBCC to share a copy of the order issued by NBCC for blacklisting of the Contractor of the New CRC Building with the Institute and Ministry of Education on priority. In view of the shortage being faced by the institute in various fronts, the NBCC be requested for deputing a Senior Official for fast tracking the issues raised by the committee constituted by BoG, SVNIT, in connection with New Class Room Complex at SVNIT Surat and to expedite decision and further action on the long pending issues of severe defects in the New CRC building by addressing the important issues of (i) Cost of rehabilitation or demolition and new construction to be borne by NBCC (ii) certification of years of safe serviceable life post rehabilitation work, if rehabilitation is decided etc.

"Further resolved to follow up with senior officials of NBCC to ensure for timely completion of repair works for the Department of Mathematics, Physics and Chemistry as per the completion target dates as committed by the representative of NBCC during the meeting i.e. Mathematics department by 30/6/2024, Physics department by 31/07/2024 and Chemistry department by 30/09/2024 positively.

The Type III quarters and Lecture Hall Complex will be completed by 30<sup>th</sup> June 2024 except for AV items in Lecture Hall Complex.

The additional cost of waterproofing will be within the overall sanctioned amount for the Renovation of the Nehru Bhavan Hostel building with other miscellaneous works and Repair and Renovation work of the Narmad Bhavan Hostel Building at the combined cost of Rs. 10,48,50,986/-. After deliberations, it was:

"Resolved to recommend to the Finance Committee and Board of Governors to approve the proposal for the Addition of New Waterproofing work including removal of existing damaged waterproofing at Nehru Bhavan Hostel Building to the Repair and renovation work of Nehru Bhavan Hostel Building including other miscellaneous works at SVNIT Campus, Surat at the estimated cost of

It was also stated that this proposal covers only part of the total boundary wall of the SVNIT campus, which is severely damaged and needs to be reconstructed. It was also discussed that in the present situation, use of precast technologies for the said compound wall would not be appropriate considering the height of the boundary wall and cost of construction considerations. On detailed deliberations, it was:

"Resolved to recommend to the Finance Committee and Board of Governors to approve the proposal of the estimate for the work of Removing and Reconstructing Compound Wall with Fixing Concertina Coil Fencing Behind Bhabha Bhavan to EWS Hostel in SVNIT, Surat for the estimated cost of Rs.1,24,90,929/-. The work will be executed through CPWD. The budget provision is to be made from OH-35/IRG. The Defect liability period for the said work should be five (05) years."

Reso. 80.17: It was informed that the renovation and major structural repairing work is required in old departmental buildings of department of Mechanical Engineering, Electrical Engineering, Chemical Engineering, Central Computer Centre, Civil Engineering Department 'A' and 'B' wings, Water Resources Engineering Lab and Advanced Hydraulics Lab at SVNIT Campus, Surat. Due to structural distresses at several locations and considerable deterioration in these departments and other buildings, which need immediate structural repair and rehabilitation to arrest and prevent further deterioration to enhance the functionality of the buildings. The estimated cost for these repair and rehabilitation work of these buildings is Rs. 34,86,13,000/-. It was informed that the HEFA rules do not permit funding for such repair and rehabilitation works. It was discussed that, in the present fund allocation under OH-35 it would not be possible to take up these works, and therefore, funding for these works are required to be approved as a special case considering its urgency, and the Ministry of Education may be requested to sanction special grant for repair of these buildings. It was suggested to submit a detailed proposal to the Ministry of Education for allocation/ sanction of special grant for repair and rehabilitation of these buildings. It was suggested to submit a detailed proposal to the ministry for allocation/ sanction of special grant to take up these repair works on priority. It was discussed that structural assessment report of these buildings will be required to proceed further. After deliberations, it was:

> "Resolved to recommend to the Finance Committee and Board of Governors for in principal approval for the Preliminary Estimates submitted by CPWD for the work of Renovation and Major Structural repairing of 1) Mechanical Engineering Department, 2) Electrical Engineering Department, 3) Chemical Engineering Department, 4) Central Computer Centre, 5) Civil Engineering Department A wing, 6) Civil Engineering Department B wing, 7) Water Resources Engineering Lab and 8) Advanced Hydraulics Lab at SVNIT Campus, Surat for the estimated cost of Rs.34,86,13,000/-, subject to allocation of special grants from Ministry for upgradation of these buildings. The work will be executed through CPWD and would be planned for completion in phased manner over a period of 2-3 years. The defect liability for the said work will be of 3 (three) years. A detailed comprehensive proposal including DPR, structure assessment report of buildings, repair and rehabilitation completion plan etc. may be submitted to the Ministry along with all other details for sanction of additional special grant for the said work in a phased manner."

- Reso. 80.18.1: It was briefed to the committee that earlier an approval was taken for procurement of furniture for the new administrative building at an estimated cost of Rs.2,81,64,953.53 to be funded through HEFA. The AV system required for New Administrative Building will be executed by CPWD. In order to have compatibility, quality and timely execution of work, it was desired that the CPWD may be entrusted to carry out this work of providing furniture in the new Administrative Building along with AV System. The CPWD has submitted a preliminary estimate for providing furniture at the cost of Rs. 2,80,50,000/-. After deliberations, it was:

"Resolved to recommend to the Finance Committee and Board of Governors to approve the proposal for procurement of Furniture for Proposed Administrative Building at SVNIT Campus, Surat for the estimated cost of Rs.2,80,50,000/-. The above mentioned work will be executed through CPWD. The budget provision is to be made from IRG/OH-35 of the institute. It will supersede the earlier resolution no. 77.09 of the B&WC and subsequent FC/BoG meeting to execute the said work through the Central store of the institute and funded through HEFA."

This initiative aims to generate additional revenue for the institute which can be utilized for enhancing infrastructure, facilities, employees and student welfare After in principal approval of BWC, a detailed study to assess the feasibility, including structural stability, municipal & legal compliances etc. will be carried out by the institute. The selection for vendor to design, installation and maintenance of hoardings will be carried out through the process of RFP. The revenue per hoarding will be based on the market rates/location. After deliberations,
