Leave of absence was noted for Professor R K Tripathi. At the outset, the Chairman welcomed all the Members present in the BWC Meeting and thanked them for sparing their time for the same. Thereafter, following agenda items were taken up for discussion:

To confirm the minutes of the 80th Building & Works Committee Meeting held Item 81.01: on 16.05.2024.

"Resolved to confirm the minutes of the 80th meeting of Building & Works Committee Reso.81.01: held on 16.05.2024".

- Item:81.02: To note the action taken on the resolutions passed at the 80thBuilding& Works Committee Meeting held on 16.05.2024.
- **Reso.81.02:** "Resolved to note the action taken on the resolutions passed in the 80thmeeting of Building & Works Committee 16.05.2024".
- Item: 81.03: To consider and note on going repair work carrying out by NBCC for the various building constructed by NBCC during 2008-2016.
- Reso.81.03: Committee was informed that the Chairman-cum-Managing Director, NBCC has been repeatedly informed about the pending complaints regarding defects in various civil works carried out by NBCC. The NBCC has taken up the repair work only in the buildings of Department of Physics, Chemistry and Mathematics, which is progressing at a very slow pace resulting into huge inconvenience to the Institute in performing academic activities. The members noted the loss being incurred by the institute due to the slow progress of repair works in the Department of Physics. Chemistry and Mathematics by NBCC. The NBCC Representative present in the meeting assured to speed up the repair works of these departments and ensured that the repair works of the following Department will be positively completed as per following time schedule:

i. Department of Mathematics - 31st December 2024;

ii. Department of Physics - 31st March 2025; and

iii. Department of Chemistry - 31st May 2025.

Regarding, New CRC Building, the members were informed that the NBCC has consented to take up the entire repair works of the building as per the methodology suggested by IIT Hyderabad. The NBCC representative informed that the tender for the repair works of New CRC Building has already been floated and the repair work is expected to start in November 2024 and the entire work shall be completed in one-year time frame. The NBCC representatives requested for the hand-over the dilapidated New CRC Building. It was advised that a written communication from NBCC should be made to SVNIT Surat in this regard for handing over of the building. The SVNIT officials requested the NBCC to share the complete repair methodology finalized by NBCC for repair works of the building, scope of the works covered in the tender floated by the NBCC and other relevant technical details finalized by them for repair and rehabilitation of New CRC Building by NBCC. Accordingly, the NBCC officials were advised to share with SVNIT all relevant details as required by SVNIT officials, along with a copy of tender document floated for the repair works. The New CRC building is ready for handover to NBCC for the repair and rehabilitation works and it will be hand over after receipt of formal requisition letter from NBCC. The committee also suggested to sign a Memorandum of understanding between NBCC and SVNIT Surat for the repair and rehabilitation works of the New CRC building. The NBCC officials

were advised that, while carrying out the repair and rehabilitation works of the New CRC building, to ensure the safety of the students and employees, after completion of repair works, the NBCC should get the structural assessment of the building done from the same experts who have suggested the repair methodology. The repair works should be closely monitored and supervised by NBCC. It was further clarified that the SVNIT will not be involved in supervision of the repair works in any manner. The NBCC official confirmed that, they will provide ready to occupy building with its design, strength and initially planned full design life, to SVNIT after completion of the repair works. On the request of NBCC officials for sharing of maintenance cost of the building, it was clearly stated that the SVNIT Surat will not provide any funds to NBCC for carrying out the repair works and also maintenance work.

Regarding the outstanding audit para regarding non providing of the lift in the Mechanical Engineering department building, the response of NBCC is still awaited. It was suggested to set up of an enquiry committee to examine the construction of buildings by NBCC at SVNIT Campus, Surat. The NBCC is yet to provide the copy of action taken against the defaulting contractor of new CRC building for blacklisting and other action. After detailed deliberations, it was:

"Resolved to request NBCC to share details of repair methodology finalized by NBCC for the repair and rehabilitation works, scope of the work covered in the tenders already floated by NBCC and other relevant technical details finalized by NBCC for repair and rehabilitation of New CRC Building, along with a copy of the tender document floated with the Institute on priority. NBCC to supervise and monitor the entire repair and rehabilitation works and to ensure completion of repair and rehabilitation works as per the committed timelines in view of the shortage of space being faced by the institute to carry out academic activities. It was also resolved that SVNIT will not provide any funds for the repair and rehabilitation works of New CRC building. To ensure the safe service life of the building, after completion of repair works, the NBCC should get the structural assessment of the building done from the same Experts who have suggested for the repair and rehabilitation methodology of New CRC Building."

"Further, resolved to sign a Memorandum of understanding between NBCC and SVNIT Surat for the repair and rehabilitation works of the New CRC building. As recommended by committee appointed by the Board of Governors, SVNIT, an undertaking may be asked from NBCC that, the safety and durability along with the

safe service life of the repaired and rehabilitated New CRC building will not be compromised. The draft MoU and undertaking should be submitted by NBCC for executing the same at the earliest."

"Further resolved to follow up with senior officials of NBCC to ensure for timely completion of repair works for the Department of Mathematics, Physics and Chemistry as per the completion target dates as committed by the NBCC representative present in the meeting i.e. Department of Mathematics by 31/12/2024, Department of Physics by 31/03/2025 and Department of Chemistry by 31/05/2025 positively."

"The NBCC to provide the required clarification in writing for the details of payments made by NBCC for the building of Mechanical Department, and justification for non-installation of lift in the Mechanical Engg building by NBCC. As informed by NBCC official in previous B&WC Meeting the NBCC be requested to share with the institute and Ministry of Education about the blacklisting of contractor and the action taken against the constructing agency of new CRC building."

"Further resolved that an enquiry committee may be appointed to critically examine the various buildings constructed by NBCC at SVNIT Campus, as per approved plan and design & specifications."

They will complete the work of the administrative building along with AV System and Furniture by 30th April 2025. The chairs installed in the Lecture Hall Complex needs review.

Item: 81.06: To recommend to the Finance Committee to approving revised estimate for the Projects to be executed in Phase-II through HEFA funding at SVNIT Campus, Surat.

The committee was informed that, the preliminary estimates for works under Phase-Reso.81.06: II for (i) Construction of 900 seater Boys Hostel and (ii) Construction of Medical Technology Research Center (Health Center) were initially submitted by CPWD as per the PAR-2021 and cost index, which was applicable at the time of the submission of the Preliminary Estimates. Additionally, the estimate of the proposed Department of Artificial Intelligence was submitted by CPWD as per the PAR-2023 as a part of HEFA Phase-II. After submission of proposal for approval from HEFA, it was suggested that the project cost for the construction work of (i) Construction of 900 seater Boys Hostel and (ii) Construction of Medical Technology Research Center अन्यम् कुव्स्ला (Health Center) were based on PAR-2021 with applicable cost index whereas the cost

Item: 81.07: To consider and approve the proposal of the Preliminary Estimate submitted by CPWD for the work of "Repairing/ Replacement of drainage line for Type 'A', Type 'C' and Sarabhai Bhavan Hostel building at SVNIT Campus, Surat" Estimated Cost Rs.46,64,159/-.

Reso.81.07: It was informed that this work involves to provide/ replacing sewer line from A type quarters, Sarabhai Bhawan, Old Sarabhai Bhawan, C Type quarters and connecting to existing manhole chamber nearest to Road and disconnecting existing sewer connections of vertical stacks and reconnecting with new sewer line as per site conditions. Reso:81.08: It was noted that, the condition of old buildings i.e. Old Production Department & Ext. Production Engineering Department (built-up area 593.06 Sq. M.), Old Guest House (built-up area 1576.00 Sq. M.), Old Hostel – II (H – 2) (built-up area 2499.00 Sq. M.) and Old Hostel - V (H – 5) (built-up area 3528.00 Sq. M.) is dilapidated and hence it is necessary to demolish the above mentioned buildings to maintain the clean campus and to avoid any unfortunate incident. The Committee also gone through the visual inspection and Condition Assessment Report of the aforesaid buildings and noted that the above Buildings are "TOTALLY UNSAFE" and NOT SUITABLE FOR HUMAN HABITAT as most of the building components are in dangerous condition and the building is showing high magnitude of distress level. During discussion, the members were of the view to review the proposal for demolition of Old Guest House in view of its usage in future and further developmental activities of the institute. The brief information about the buildings for demolition is tabulated below:

According to the Gujarat High Court letter No. FES/Outward/1401/6, Dt. 03/08/2024 (Enclosed herewith), it is mandatory for all educational buildings with a height exceeding 9 meters and an area exceeding 500 m2 to obtain a Fire Safety NOC. The proposed consultant will identify the defects and loops and propose detailed requirements to maintain fire safety systems in 54 buildings. They will also help apply to Fire Safety NOC and be responsible for regular monitoring and reporting on fire operations and drills in line with SMC guidelines. Therefore, quotations from SMC-approved consultants were invited to provide Annual Maintenance Contract (AMC) requirements for NOC for Fire Safety. After deliberations, it was:

"Resolved to approve the proposal to appoint the M/s. Northern Star Engineering SMC approved consultant for the work of Fire Safety No Objection Certificate (NOC) requirements for various buildings at the SVNIT Campus, Suratat the estimated cost of Rs.9,55,800/-. Reso. 80.18.1:It was briefed to the committee thatthe 77th BWC meeting approved the proposal for the work of Repairing, Servicing, and Overhauling of 750 KVA, 22/0.433 kV, ONAN type transformer for Substation-5 in the SVNIT campus, Surat through CPWD at estimated amount of Rs.9,35,000/-. However, as informed by the CPWD, the initial estimation is old and the present condition of the transformer require additional tests for which a new estimate of Rs. 11,25,501/- has been submitted. The said transformer is out of service for more than 1 year. The CPWD has requested to go for tender by the competent authority for sanction of additional amount if the tender cost exceeds the sanctioned amount. Now the CPWD vide letter dated 14/10/2024 informed that the cost of Lowest (L1) bidder is Rs. 10,26,661/-. Further, the CPWD is requesting for an additional Rs. 5,13,331/- (50% of L1 Price) as an expense towards any extra/deviation which may crop up at the time of execution of the said work. The total amount requested by CPWD including deviation/extra amount of work, contingency, EPF &ESI charges is Rs. 17,13,498/-.

After deliberations, it was:

"Resolved to approve proposal for Repairing, Servicing, and Overhauling of 750 KVA 22 kV/0.433, ONAN type transformer for Substation-5 in the SVNIT campus, Surat through CPWD till the expenditure of tendered amount i.e., Rs.10,26,661/-.
