In this context, on the basis of plan area and amenities/facilities required CPWD has given approximate rough cost estimated for the said five buildings. During the recent visit of Dean Planning & Development and Associate Dean, Planning & Development at MHRD Office, revision of the proposal is suggested by the Ministry.

Looking to the requirement of revision for enabling ministry to process the proposal, it was unanimously decided to obtain preliminary estimates (P.E.) for the said buildings. As a result, the above estimated cost can vary upwards further due also to demolition of old quarters and hostels is to be carried out for projects at Sr. No. 1,2,3 and 5.
