At the outset, Prof. S. R. Gandhi, Director and the Chairman, welcomed all members to the 36th meeting of Finance Committee. He specially welcomed the MHRD members, Shri Madan Mohan, Additional Director General (HE) and Shri D. K. Singh, Deputy Secretary (IFD) for sparing their valuable time. He also thanked them for all the guidance and support to SVNIT, Surat.

The members were informed about the new members in the Finance Committee as Board Nominee:

- a) Dr. R. A. Christian, Professor in Civil Engineering Department who is an Environmental Engineering expert and has served the Institute in various capacity of Dean (P&D), Dean (SW), etc.
- b) Dr. P. V. Bhale, Associate Professor in Mechanical Engineering Department who has expertise in Energy from alternate sources, served the Institute in the capacity of Associate Dean (R&C) and he is also a member of GUCOST Project Review Committee.

The members were also informed about the new Registrar, Dr. Pramod Mathur who has joined the Institute on 11th February 2020 as a new Member Secretary of Finance Committee. He also placed on records the services rendered by the former In-charge Registrar, Dr. K. D. Yadav and thanked him for his contribution, particularly in resolving long pending MACP issues, various inquiries, etc. The Chairman requested the members to permit Dr. K. D. Yadav and Dr. P. V. Timbadiya as special Invitee to the Finance Committee which was agreed by all.

Thereafter, the Member Secretary was requested to go through the agenda items.

- Item 36.1: To confirm the minutes of the 35th meeting of the Finance Committee held on 09/01/2020.
- **Reso36.1:** "The draft minutes of the 35th meeting of the Finance Committee held on 09/01/2020 were circulated to all members on 27/01/2020for their review and comments, if any. No comments were received on minutes of 35th Finance Committee Meeting. Hence, the Finance Committee "resolved to confirm the minutes of 35th Finance Committee meeting".

The typographical error in the agenda Item-1 'The minutes of the 34th meeting of the Finance Committee is placed...' (page 1 of 110) was corrected as 'The minutes of the 35th meeting of the Finance Committee is placed....' and 'Minutes for the 36th meeting of the Finance....' (page 2 of 110) be corrected as 'Minutes for the 35th meeting of the Finance....'. The members noted the above corrections.

- Item 36.2: To note and approve the action taken on the resolutions adopted by the Finance Committee in its 35th meeting held on 09/01/2020.
- Reso 36.2: The Finance Committee noted the action taken on the resolutions adopted by Finance Committee in its 35th meeting held on 07/01/2020. While discussing the action taken in the agenda Item 5, the MHRD representative expressed their concern for possibility to reduce the manpower in security services by installation of CCTV camera at prominent places in the campus. Also, the institute was advised to propose redistribution of non-teaching posts (Officer Cadre) as per its requirement of the institute for approval from MHRD.

Further, it was also suggested that, Institute should raise the proportionate bill to IIIT, Surat for the expenditure incurred for deployment of manpower in the campus for the services rendered to IIIT Surat.

As per the Resolution No 18 of 35th Finance Committee meeting, Institute recouped the negative balance in OH-31 and OH-36 from Internal Resource Generation (IRG). Furher, the Finance Committee was informed that institute has transferred a sum of Rs. 1.06 Crore to OH-31 and Rs. 25.31 Crore to OH-36 from IRG for excess expenditure shown in relevant head during Financial Year 2017-18.

Furthermore, the institute also informed that, excess expenditure made in Financial year 2018-19 is expected to be settled in financial year 2020-21 and 2021-22 from IRG.

The Finance Committee advised institute to submit appropriate fund utilization plan for OH-35 as per availability of fund.

Also, efforts should be made to settle all outstanding audit paras within the institute. The list of all outstanding paras be placed before ensuing Finance Committee/Board.

Further, MHRD officials clarified that no additional fund will be made available for this purpose. The Institute has to manage the same through Internal Revenue Generation (IRG) of the Institute. The Capital expenditure mentioned in **APPENDIX:36.4** may be made under OH-35 for which funds are physically available after transfer of funds from institute IRG to OH-31 & OH-36 for the financial year 2017-18.
