The plan for Construction of 80 Nos. of Residential Quarters (Type-IV) was prepared by empaneled architect M/s. Pavan Infratech, Surat and preliminary estimate was prepared by CPWD. This proposal is part of five years infrastructure development plan for 2020-25 and will be executed through funding from HEFA. This will consist of two blocks of 40 quarters in each block with G+10 storyed with GRIHA 3 Star rating compliant design having Ground in stilt for parking and other 10 floors with floor height of 3.00 meter. The total construction area of the proposed buildings is 14718.90 sqm.

The proposed plan and preliminary estimates were prepared after series of meetings with CPWD officials and Architects. The plans and preliminary estimate was prepared by CPWD and was placed before 68th meeting of Building & Works Committee held on 19/08/2020 wherein it was recommended to approve the preliminary estimate of Rs.46,08,32,350/- (Forty Six Crores Eight Lakhs Thirty Two Thousand Three Hundred Fifty only) including 3% contingencies charges and 4.25% of EPF & ESI for Construction of Residential Quarters (Type-IV) at SVNIT, Surat which will be executed by CPWD and funded through HEFA Loan. After deliberation it was:

"Resolved that proposal for getting the HEFA loan under Phase- I be initiated for above three approved projects at the earliest. The proposal for Phase-II and Phase- III will be initiated as per time line mentioned against each. The construction work under Phase – II and Phase- III will be taken-up depending upon the institute priorities and availability of funds and be brought to Finance Committee in near future for approval before construction of the Buildings."

The total construction area of the proposed building is 880.00 sqm. The Building & Works Committee in its 68th meeting held on 19/08/2020, recommended the preliminary estimate of Rs.3,96,98,772/- (Rupees Three Crores Ninety Six Lakhs Ninety Eight Thousand Seven Hundred Seventy Two Only) including 3% contingencies charges and 4.25% of EPF & ESI (excluding Medical Equipment and Furniture) and also resolved to execute the work through CPWD. Considering the local climatic conditions, provision should be made for airconditioning in all rooms of proposed health center. In addition, the Furniture & Fixture and equipment required for the health center is estimated to Rs.49.07 Lakhs which will be procured by the institute. The entire project cost including building, medical equipment and furniture will be funded through HEFA. After deliberation it was;

"Resolved to recommend to the Board of Governors to approve in principle the preliminary estimate submitted by CPWD for 600 Seater Boys' Hostel at SVNIT, Surat (including Furniture) at the estimated cost of Rs.49,15,92,800/- (Rupees Forty Nine Crore Fifteen Lakhs Ninety Two Thousand Eight Hundred only) including 3% contingencies charges and 4.25% of EPF & ESI which is to be executed by CPWD and funded through HEFA Loan subject to availability of funds and priority".

The total construction area of the proposed building is 34398.61 sqm. The plan is prepared through empanelled architect M/s. Mitimitra Consultant of Pune and the preliminary estimate is prepared by CPWD. The Building & Works Committee in its 68th meeting held on 19/08/2020 recommended the proposal with the preliminary estimate of Rs.23,14,00,100/- including 3% contingencies charges and 4.25% of EPF & ESI as prepared by CPWD and also resolved to execute the work through CPWD. The Committee advised that the institute should explore the possibility for getting funding from other sources/agencies/ alumni association to reduce HEFA funding and reduce IRG spending. After deliberation it was:

"Resolved to recommend to the Board of Governors to approve in principle the preliminary estimate submitted by CPWD for Construction of Out Door Sports Facility (Synthetic Athletic Track, Cricket and Foot Ball Ground) at SVNIT, Surat at the estimated cost of Rs.23,14,00,100/- (Rupees Twenty Three Crore Fourteen Lakhs One Hundred only) including 3% contingencies charges and 4.25% of EPF & ESI which is to be executed by CPWD and fully/partially funded through HEFA Loan subject to availability of funds and institute priorities".

Reso39.8: The Committee was briefed that, for implementation of EWS Reservation at SVNIT Surat the MHRD, Gol had allocated a fund of Rs.29.83 crore under OH-35 vide letter No. F. No. 35-4/2019-TS.III dated 19/06/2019 including Rs.25.66 crores for constructions, Rs.1.74 crores for equipment and Rs.2.43 crores for Furniture. Earlier, the Detailed Project Report (DPR) for additional Infrastructure required for implementation of reservation for Economically Weaker Section (EWS) was approved by 34th Meeting of the Finance Committee & 51st Board of Governors meeting held on 10/10/2019. The DPR included Construction of Hostel at the estimated cost of Rs.25.66 Crores including contingencies, EPF & ESIC as per preliminary estimate by CPWD. The original preliminary estimate was based on tentative area without any detailed planning of the proposed hostel building. Now on detailed architectural planning, the minimum total required plinth area for 500 student hostel on double occupancy basis has considerably increased from 7600 sqm to 9600 sqm,

The Building & Works Committee in its 68th meeting held on 19/08/2020 recommend for administrative approval/ expenditure sanction for the work of Construction of 500 Seater Boys' Hostel at SVNIT, Surat excluding furniture as per the revised preliminary estimate of Rs.35,47,77,283/- [Rs.36,46,45,896 (-) 98,68,613 towards furniture cost] including 3% contingencies charges and 4.25% of EPF & ESI. The work will be executed through CPWD and funded by HEFA (EWS) and IRG of the institute. The funding through HEFA (EWS) will be limited to Rs.25.65 Crores and remaining Rs.9.83 Corers will be funded through IRG of the Institute. The additional expenditure involved for completion of the project over and above the admissible amount of HEFA loan will be met out from IRG of the institute. The institute will procure equipment of Rs.1.74 Corers and furniture Rs.2.43 Cores separately, which will be funded through HEFA (EWS) following GFR procurement procedure. The Ministry officials emphasized that the construction should be as per funds approved by the Ministry of Education for EWS Project implementation and fund sanctioned cannot be increased.

The Ministry officials present in the meeting informed the Committee that the fund of Rs.29.83 Crores (Rs.25.66 Crores for Construction, Rs.1.74 for equipment & Rs.2.43 Crores for furniture) sanctioned to SVNIT, Surat under HEFA (EWS) will now be met through GIA of Ministry of Education instead of funding through HEFA (EWS), After deliberation it was;

- Item 39.10: To consider and recommend to Board of Governors to approve the amount of consultancy fees for Consulting Services for various projects to be taken up in SVNIT Campus under HEFA met out of the Contingency Component of preliminary estimate submitted by CPWD.
- Reso39.10: It was informed to the committee that the institute hired the services of empaneled Architect/Consultants for upcoming various projects in the campus based on their project presentation and capacity to execute the size of projects in terms of their cost. The empaneled Architects were categorized into three groups which was approved by 62nd meeting of BWC held on 1.3.2018. Out of 11 HEFA Projects, the planning and designing component of 07 projects have been carried out through outsourced consultancy firms. The expenditure for consultant fees is proposed to be met from the 3% contingency amount kept in the respective projects which will be undertaken by CPWD. The institute has already paid approx. 10% of the consultation fees to three Architects. The representative from Ministry of Education express that the Architectural Fees of the approved projects can be managed by CPWD from the contingency amount available in respective projects. After deliberation, it was:

R. O. Agrawal of Surat
- The Committee was briefed that, the work for Renovation of Old Library Building Reso 39.11: (Incubation Center) at SVNIT Campus, Surat was approved in the 35th meeting of Finance Committee meeting held on 9.1.2020 with total cost of Rs.1,57,62,286/-. During execution of work, seepage of rain water from external walls, terrace and from the existing roof was observed. Moreover, during site visit, it was found necessary to execute some extra items like strengthening of damaged structural members like beams, columns etc. with the use of polymer plaster in order to ensure structural durability of the building. Also some extra items are required to be added as per suggestion of Architect like epoxy grooving in wall tiles and wall putty work, drainage line chamber work etc. Accordingly, the estimate of above referred extra items for Renovation of Old library (Incubation Center) has been prepared based on the CPWD DSR 2016. The work has been executed by the Maintenance Unit of the institute. The matter was placed before the Building & Works Committee in its 69th Meeting held on 11/11/2020 and the Committee has resolved to recommend to the Finance Committee/ Board of Governors to approve the amount of extra items of Rs.23,13,250/- (Rs. Twenty Three Lakhs Thirteen Thousand Two Hundred Fifty only) to be executed under the work of Renovation of Old Library Building (Incubation Center) at SVNIT Campus, Surat. This will be over and above the total cost of Rs. 1,57,62,286/- already sanctioned earlier. After deliberation, it was:

"Resolved to recommend to the Board of Governors to approve the amount of extra items of Rs.23,13,250/- (Rupees Twenty Three Lakhs Thirteen Thousand Two Hundred Fifty only) to be executed under the work of Renovation of Old Library Building (Incubation Center) at SVNIT Campus, Surat through which is over and above the total cost of Rs. 1,57,62,286/- already sanctioned earlier. The expenditure be met under OH-31".

Reso 38.12: The Committee was briefed that, the work of Renovation, up-gradation and repairing of 96 Nos. of student rooms and toilet block and others miscellaneous works in Hostel Building (Old Wings of Gajjar Bhavan) was awarded to CPWD with the estimated cost of Rs.76,03,300/- (including GST, contingencies charges, ESI and EPF as applicable from time to time). The CPWD informed that during chipping out the unsound/weak concrete of slab, it was observed that the condition of RCC structure were not good. The concrete has bulged out at many places due to improper cover to the reinforcement and severe corrosion of the reinforcement bars. The reinforcement bars are severely damaged and separated from the unsound concrete. The structural strengthening work means increasing the safety of the structure by repairing the structural elements like beam, slab and column etc. Looking to the serviceability of the parent structure and to ensure the safety, the matter was placed before the BWC in its 69th Meeting held on 11/11/2020 and the BWC recommended for cancellation of the said work and to approve the proposed conversion and Renovation of 6 nos. existing Hall into 74 rooms and adding additional toilet blocks and amenities in Gajjar Bhavan hostel-4 at SVNIT, Surat. The preliminary cum detailed estimate may be prepared by CPWD for the said work. A fresh approval will be obtained from FC/BoG of the Institute through BWC of the Institute. After deliberation, it was:

"Resolved to recommend to the Board to cancel the work of Renovation, upgradation and repairing of 96 Nos. of student rooms and toilet block and others miscellaneous works in Hostel Building (Old Wings of Gajjar Bhavan) entrusted to CPWD and to demolish old wing for better ventilation and fire safety."
