At the outset the Director warmly welcome the Chairman, BoG, Professor Bhim Singh alongwith all the members present. After preliminary discussion, following agenda items were taken up for discussion:

- **Reso 49.02:** While discussing the action taken report on Resolution no. 48.05 regarding submission of HEFA loan application under phase-II, it was advised that while submission of HEFA Phase-II loan application to the Ministry, the Institute should submit complete next 5 years construction plan alongwith HEFA Phase-II loan application.
 - "Resolved to note the action taken on the resolutions adopted by the Finance Committee in its 48th meeting held on 07.11.2023."
- Item 49.03: To note the minutes/recommendations of the 78th Meeting of the Building & Works Committee held on 30.11.2023 and 79th Meeting of Building & Works Committee held on 14.02.2024.
- Reso 49.03: "Resolved to note the recommendations of the 78th Meeting of the Building & Works Committee held on 30.11.2023 and 79th Meeting of Building & Works Committee held on 14.02.2024."
- Item:49.04: To consider and recommend to the Board of Governors to approve the modified estimates and specifications of AV system for New Administration Building and Two Lecture Hall Complex at SVNIT Campus, Surat.
- Reso.49.04: It was informed that under the HEFA Phase-I project, one New Administrative building, Two Lecture Hall Complexes and Type 80 Nos. III Residential Staff Quarters are under construction by CPWD and it is expected to be completed shortly. In the preliminary estimates of the Administrative Building and Lecture Hall Complex, a sum of Rs.182.50 lakhs was considered for providing AV system in this projects with limited equipment with Audio Visual System (AV System) for the Senate Hall/ Class Room Complex. Later on it was decided to explore the provision of AV system for the Board Room, Conference rooms, Offices, meeting rooms and the Video Wall at Entrance Lobby and display screens at various locations. The changes in the modified provision of the AV system for the new Administrative Building and Two Lecture Hall Complexes will revise the estimated cost to Rs.5,13,04,706/-. After deliberations, it was:

F.No.16-2/2017-TC from MHRD on dt.16/07/2018 only the works in the priority list would be funded. Therefore, no funding from HEFA will be permissible for the renovation/repair of old buildings. After deliberations, it was:

"Resolved to recommend to the Board of Governors to approve the estimate of Rs.4,25,47,313/- (Rupees Four Crore Twenty Five Lakhs Forty Seven Thousand Three Hundred Thirteen only) for the work of Special Repair/Renovation and up-gradation of Toilet Unit of Students Rooms and other Misc. development work in Raman Bhavan Hostel Building at SVNIT Campus, Surat. The work will be executed through CPWD and the expenditure will be met under OH-35."

"Further resolved that, the existing hostel seat rent charges including Raman Bhavan Hostel be reviewed. Suitable hostel fee revision may be made according to the cost and facilities being provided by the institute."

This will be additional work and was not covered under HEFA Phase-I Projects (Administrative Block, Two Lecture Hall Complexes and Type III Staff Quarters). After deliberations, it was:
