







Item: 1	To confirm minutes of the 42nd meeting of IAAC held on December 16, 2019. As requested by Head of Mechanical Engineering department, the last sentence of Reso. 30 of 42 nd IAAC meeting is modified as: “In this regard, department is encouraged to conduct workshops for restructuring/renaming of PG programs seeking financial assistance from TEQIP-III.”
Res. 1	The minutes of 42 nd meeting of IAAC is confirmed.
Item: 2	To discuss the grade criteria proposed in Annexure-C of 42 nd IAAC (Resolution 6) for Credit transfer of NPTEL/SWAYAM courses completed by Ph.D. Students.
Res. 2	After deliberation and taking into consideration Point 16 (a) in revised Ph.D. regulations implemented since July 2019, the grade criteria for Credit transfer of NPTEL/SWAYAM courses is revised as attached in ANNEXURE – A.
Items from Chair	
Item: 3	To discuss the Grade code to be followed for Audit Course on “Holistic Empowerment and Human Values” in First Semester.
Res. 3	It is resolved to award following two grades for Audit Courses. NP- Pass in Audit course. NF- Fail in Audit course
Item: 4	To discuss the implication of merging of Civil Engineering Department and Applied Mechanics Department.
Res. 4	Chairman of IAAC opened up the discussion on merging of Civil Engineering Department and Applied Mechanics Department. Associate Dean (P&D) insisted that autonomy of sections in the merged department be preserved. He also insisted that the funds generated from consultancy and testing of individual sections be allowed for development of laboratories pertaining to that section. Chairman agreed on the issue of autonomy of each



section. However Dean (R&C) and Incharge Head of Civil Engineering Department pointed out that the revenue generated from consultancy and testing of different sections in a department is not segregated and it is not possible to use the revenue generated by one section separately for the development of laboratories of that section only. Dean (Academic) proposed that with renewed faculty strength of the department, the merged department of Civil Engineering should propose new UG program on "Infrastructure Technology".
