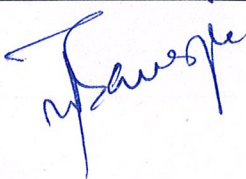

Item: 2	To finalize the Academic Calendar for first year M. Tech. and newly admitted Ph D students for Autumn Semester (Odd) of Academic year 2020-21 in view of COVID-19 Pandemic.
Res. 2	Academic Calendar for first year M. Tech. and newly admitted Ph D students for Autumn Semester (Odd) of Academic year 2020-21, attached in Annexure 2.1 , is approved. It is proposed to include 1 st week of February as the schedule for Comprehensive Examination of Ph D students of odd semester in Academic calendar for Spring (Even) semester.
Item: 3	To propose Academic Calendar for First year UG (B. Tech. and M.Sc. Integrated) students for Autumn Semester (Odd) of Academic year 2020-21 in view of COVID-19 Pandemic.
Res. 3	The Academic Calendar for First year UG (B. Tech. and M.Sc. Integrated) students for Autumn Semester (Odd) of Academic year 2020-21, attached in Annexure 3.1 , is approved. It is proposed to mention a note in the academic calendar that the dates for offline classes will be intimated later depending on COVID-19 pandemic scenario.

The house agreed to recommend to the Institute Senate the change in name of the department with the condition that the department will ensure "Applied Chemistry" as a subset of the department and will augment more collaborative research with Engineering Departments. In addition, the department should encourage more Ph D and Senior M. Sc. students to opt for courses from Engineering Disciplines. Also, the department should offer more courses related to Applied Chemistry to be opted by Engineering students.

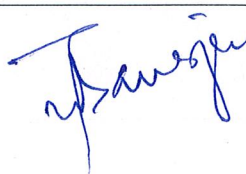

The house agreed to recommend to the Institute Senate the change in name of the department with the condition that the department will ensure “Applied Physics” as a subset of the department and will augment more collaborative research with Engineering Departments. In addition, the department should encourage more Ph D and Senior M. Sc. students to opt for courses from Engineering Disciplines. Also, the department should offer more courses related to Applied Physics to be opted by Engineering students.

Res. 7	After lot of deliberation it was resolved that Computer Engineering Department can prepare the syllabus for Research Methodology and get it recommended by their DAAC such that it should cater to the requirement of PhD students for whole institute. The recommended syllabus by DAAC will be discussed in the next IAAC meeting visa-vis the existing syllabus in Research Methodology. The revised syllabus, if found appropriate, will be applicable from Academic Year 2021-22.
Item: 8	To consider the recommendation of meeting of DAAC Electronics Engineering Department held on July 31, 2020 to review and remove the



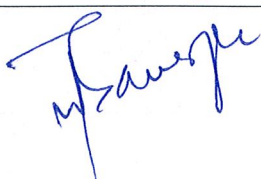
