Item No. 1	To approve the minutes of the 10 <sup>th</sup> ICSRB meeting held on 8 <sup>th</sup> October 2021 at 4:00 pm at Institute Conference Room, New Administrative Building, SVNIT, Surat.
Reso. No. 1	The minutes of the 10 <sup>th</sup> ICSR Board meeting held on 8 <sup>th</sup> October 2021 were circulated via email to all the members, and no comments were received in a stipulated period. The ICSR Board, therefore, confirmed the minutes as placed in Annexure–I.
Item No. 2	To note and approve the action taken on the resolutions adopted in the 10 <sup>th</sup> ICSR Board meeting held on 08 <sup>th</sup> October 2021.
Reso. No. 2	The actions taken on the resolutions adopted in the 10 <sup>th</sup> ICSR Board meeting held on 08 <sup>th</sup> October 2021, were noted and approved by the Board as placed in Annexure-II.
Item No. 3	To review, discuss and resolve whether to continue the practice of encouraging the faculty members to file the applications for the Design Registrations of their innovations and to continue to reimburse the expenditure towards the same. This is in view of encouraging faculty more towards filing of the patents as compared to the Design Registrations. The ranking parameters set by the National Institutional Ranking Framework (NIRF also does

	not include the Registration of Design.
Reso. No. 3	The item was discussed in length. It was observed that the Design Registration is only an initial step towards eventual filing of patents (Process, Product, etc.) for the innovations done by the faculty members and the research scholars. Hence, with a focus on encouraging the faculty members towards filing of the patents (Process, Product, etc.), as compared to the Design Registrations, it was resolved to discontinue the current practice of providing financial assistance for filing the design registrations. The form for Administrative & Financial Approval for Patent Filing Expenses is to be re-designed by the Dean (R&C) Office.
Item No. 4	To discuss and resolve the upper permissible financial limit related to the Patents Expenditure under the Patent Attorney Code 1/380 for faculty members during a financial year and the methodology for effective implementation.
Reso. No. 4	The board had noted the approval notes of Dean(R&C)/2021-22/10589 dated 21.12.2021 and Dean(R&C)/2021-22/12150 dated 28.03.2022. It was resolved that the financial assistance for patent related expenses (filing, FER charges, Patent Renewal charges etc.) will not be given from any of the SVNIT funds e.g. SRP Fund/CPDA Fund/PUF-POH will not be given from any of the SVNIT funds e.g. SRP Fund/CPDA Fund/PUF-POH Fund/Patent Attorney Fee Code (1/380); if SVNIT, Surat is not registered as an applicant. However, the institute will pay all the expenses (as per the prevailing rules/ceiling) for the transfer in the name of the institute, for the older patent applications
