Dr. R. A. Christian, Professor, Deptt. of Civil Engg., SVNIT, Surat could not attend the meeting. At the outset the typo error in the index page and 1st page of Agenda regarding date and time were noted and corrected. The following items were discussed:

Item 94.1: To confirm the minutes of the 93rd Purchase Committee meeting held on 30th August, 2022.

Item 94.2: To note and approve the action taken on the resolutions adopted by the Purchase Committee at its 93rd meeting held on 30/08/2022.

Reso.94.2: *“Resolved to note the action taken on the resolutions adopted by the Purchase Committee in its 93rd meeting held on 30/08/2022.”*

Item 94.3 : To consider and recommend for purchase of Rotary Evaporator for Department of Chemistry from M/s. Buchi India Private Limited, Mumbai at the total cost of Rs. 6,96,792/- including all taxes and expenditure will be met from Annual Plan Grant (OH-35).

Reso.94.3: It was informed to the Committee that, the procurement process was carried out through GeM portal as per GFR-2017. It was informed to the Purchase Committee that, the approval was taken for two items, but the indenter floated the bid for only one item as the other item is not available on GeM and both the items are independent in nature. After deliberation it was,

“Resolved to recommend to approve purchase of Rotary Evaporator for Department of Chemistry from M/s. Buchi India Private Limited, Mumbai at the total cost of Rs. 6,96,792/- including all taxes and expenditure will be met from Annual Plan Grant (OH-35) with other terms and conditions as stated in the offer.”

“Further, it is resolved that details related with all taxes / GST percentage should be clearly indicated (Total Amount = Quoted Rate + % of GST) while releasing the purchase order.”

“Resolved, further that, the necessary training should be provided to the concerned institute employees if required and payment be released only after satisfactory installation, Commissioning and Training of above item.”

Item 94.4: To consider and recommend for purchase of fluorescence microplate reader (multimode microplate reader) for Department of Chemistry from M/s. Biotron Healthcare (India) Private Limited, Mumbai at the total cost of Rs. 8,40,000/- including all taxes and expenditure will be met from Seed Money Project (2021-22/DoC/19) under Annual Plan Grant (OH-35).

Reso.94.4: It was informed to the Committee that, the procurement process was carried out through GeM portal as per GFR-2017. After deliberation it was,

“Resolved to recommend to approve purchase of fluorescence microplate reader (multimode microplate reader) for Department of Chemistry from M/s. Biotron Healthcare (India) Private Limited, Mumbai at the total cost of Rs. 8,40,000/- including all taxes and expenditure will be met from Seed Money Project (2021-22/DoC/19) under Annual Plan Grant (OH-35).”

“Further, it is resolved that details related with all taxes / GST percentage should be clearly indicated (Total Amount = Quoted Rate + % of GST) while releasing the purchase order.”

“Resolved, further that, the necessary training should be provided to the concerned institute employees if required and payment be released only after satisfactory installation, Commissioning and Training of above item.”

Item 94.5: To consider and approve the extension of existing online Application Portal Module for recruitment for Faculty and Non-Faculty posts to M/s. Master Soft ERP Solutions Pvt. Ltd., Nagpur (M/s. MasterSoft ERP Solutions Pvt. Ltd., Nagpur) at the total cost of Rs. 5,81,740/- including all taxes and expenditure will be met from OH-31.

Reso.94.5: The committee noted that the service contract with M/s. Master Soft ERP Solutions Pvt. Ltd., Nagpur (M/s. MasterSoft ERP Solutions Pvt. Ltd., Nagpur) for providing online Application Portal Module for recruitment for Faculty and Non-Faculty posts has already been completed on 28.02.2022. Hence, the Committee was not agreed to the proposal for extension of online Application Portal Module. However, the same may be placed again before Purchase committee after receiving of fresh proposal. After deliberation it was:

“Resolved to withdraw the proposal.”



“Resolved, further that, the necessary training should be provided to the concerned institute employees if required and payment be released only after satisfactory installation, Commissioning and Training of above item.”




