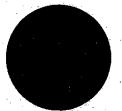

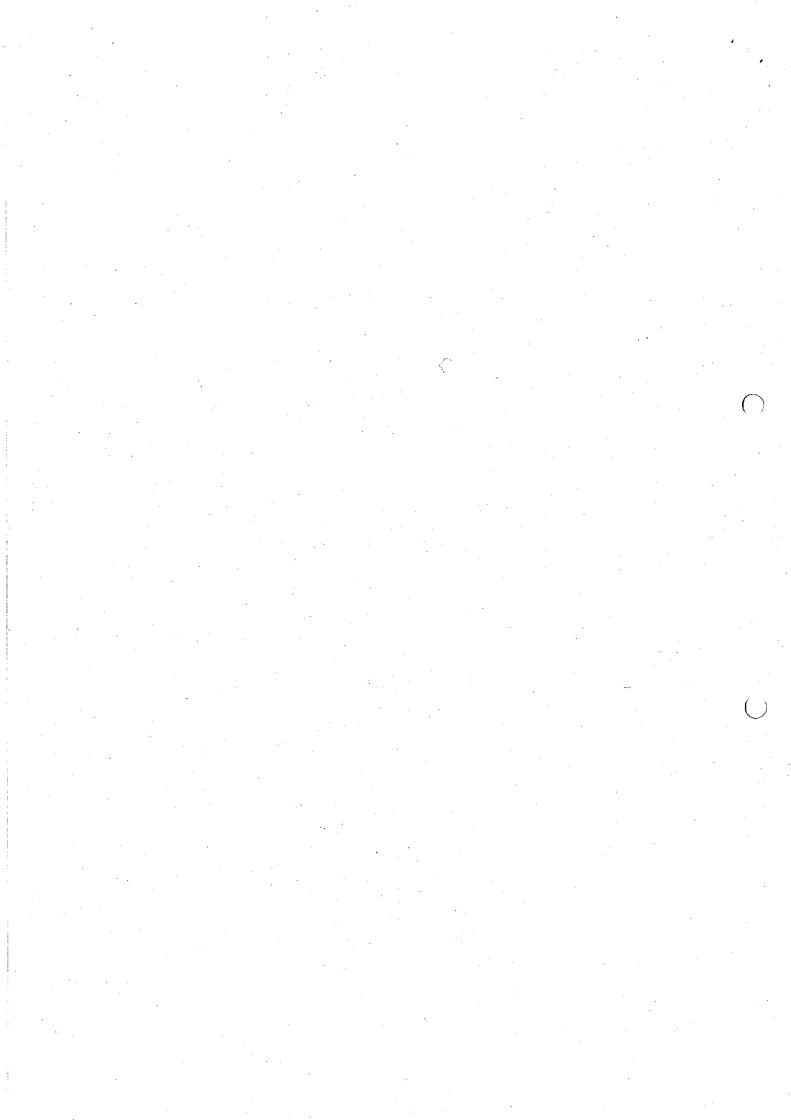

- Item 87.2: To note and approve the action taken on the resolutions adopted by the Purchase Committee at its 86th meeting held on 10/01/2022.
- Reso.87.2: "Resolved to note the action taken on the resolutions adopted by the Purchase Committee at 86th meeting held on 10/01/2022."
- Item 87.3: To consider procurement of Customized Vibration Analysis Equipment and allied accessaries.
- Reso.87.3: The procurement process was made through GeM Potal. Some discrepancies were noted in the estimated cost indicated in the indent and submitted note. Out of total four bids only one bid was qualified for financial evaluation. During discussion, it was clarified by the indentor (Dr Rohit Tamrakar) that there was error in the estimated cost which should be read as Rs. 13,50,000/at all places. It was also advised that the Techno-commercial comparision sheet should have final recommendation of the committee. After deliberation it was:

"Resolved to recommend to approve purchase of Customized Vibration Analysis Equipment and allied accessories from M/s. TIERA Pvt. Ltd. Trivandrum, at total cost of Rs.12,98,430/- (Rupees Twelve Lakh Ninety Eight Thousand Four Hundred & Thirty Only) including 5% GST with other terms and conditions as stated in the offer from the Non Recurring part of Seed Money Grant for Department of Mechanical Engineering".

Royal Electronics Sales & Services, Vadodara for Department of Electronics Engineering. The expenditure will be made from OH-35."

Ltd. for Department of Physics. The expenditure will be made from SERB Project Grant (SERB 4/267)."

- Item 87.6: To consider proposal for Annual Maintenance Services for Toshiba Copier Machines at SVNIT, Surat
- Reso.87.6: The members observed that the proposal for Annual Maintenance Service Contract (AMC) is for 32 Nos. Toshiba Copier Machines and the amount of Annual Maintenace Services Contract per machine is Rs.19138.63x1, 34374.52x19, 51315.45x12. In addition to the AMC amount, the institute has also to pay for other consumables i.e. Toner Cartridges/Drumkit/Heater/Fuser kit/Transfer Belt/Transfer Blade/Lamps/Control Panel/Plastic Body parts for each machine as per requirement. Considering the information/ data provided by the departments/sections, the committee observed that the AMC amount is on higher side and is not economical as per the usage of copier machines at various places. It was suggested to get the FSMA offer from the firm where ever possible. After deliberations, the committee opined not to go for Annual Maintenace Service Contract for Toshiba Copier Machines as per the quoted rates. Therefore it was:

"Resolved not to recommend for Annual Maintenance Services for Toshiba Copier Machines at SVNIT, Surat as per present offer."

"Further, resolved that, the Repair & Maintenance of Toshiba Copier Machine be made at Department/ Section level as per the Rules of the Institute."

"Possibility to be explored to get the reasonable Full Service Maintenance Agreement (FSMA) of Toshiba Copier Machine by the respective Department/Section".

The expenditure will be made from OH-35."

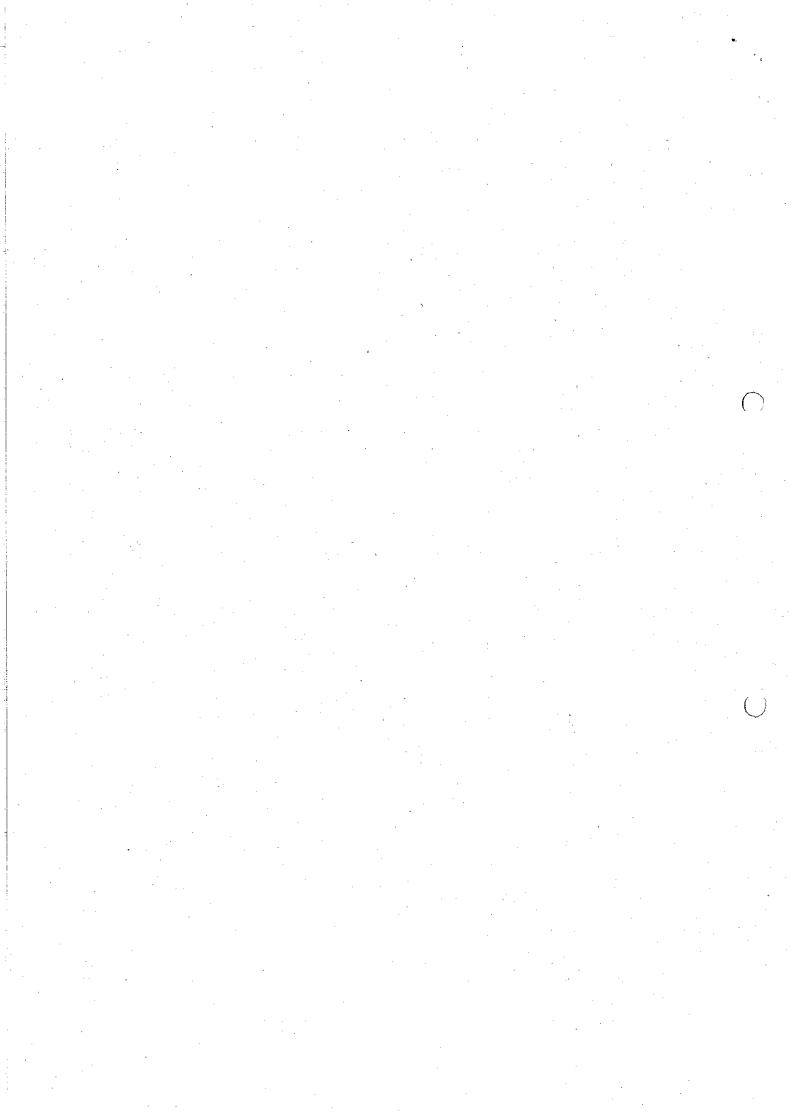
