The following business was transacted and resolutions were drawn accordingly:

Item 1: To confirm the minutes of the 74thPurchase Committee meeting held on Saturday, the 29th February, 2020 at 11:00 a.m.

Reso.1: "Resolved to confirm the minutes of the 74th Purchase Committee meeting held on Saturday, the 29th February, 2020 at 11:00 a.m.

- Item 2: To note and approve the action taken on the resolutions adopted by the Purchase Committee at its 74th meeting held on 29/02/2020.
- **Reso. 2:** "Resolved that the action taken on the resolutions adopted by the Purchase Committee at its 74th meeting held on 29/02/2020 be noted and approved."
- Item 3: To consider and approve the proposal of Principal Investigator of Applied Physics Department through Dean (R&C) for purchase of GNSS Receiver for lonospheric Scintillation and Signal Refractometer and Simulator (complete system installation and commissioning) from M/s. Jyoti Electronics, Ahmedabad at the total cost of Rs. 18,28,600/- (Rs. Eighteen Lacs Twenty Eight Thousand Six Hundred Only) excluding Taxes and Duties (customs, GST etc.) with three years warranty and other terms and conditions state in his offer under DST FIST Project Budget Head (4/256).
- Reso. 3: The Committee observed that, the Departmental Tender Committee has not considered and recommended for purchase of "Notebook (i7 or compatible or better) with international key board, suited for real time data signal recording and processing", which was mentioned as essential item in the Tendered specification. Further, the supplier M/s Jyoti Electronics, Ahmedabad in their quotation also quoted for additional items which were not recommended for purchase. The party has charged and quoted Rs.82,000/- for shipment and handling, Rs.50,000/- towards extra freight insurance & custom duty handling charges as actual, Rs.7,33,080/- towards custom (@30%) and Rs.5,80,802/- as taxes extra, which needs justification. The justification for price reliability is also required in view of single valid quotation. Therefore, after due deliberation, the purchase committee adopted following resolutions;

"Resolved to refer back the recommendation of Departmental Tender committee to the department to review for the purchase of GNSS Receiver for lonospheric Scintillation and Signal Refractometer and Simulator (complete system installation and commissioning) for Applied Physics Department under DST-FIST project."

Item 4: To consider and approve the proposal of Principal Investigator of Applied Physics Department through Dean (R&C) for supply of Thermal Properties Measurement System from M/s. LCGC Bio Analytic Solutions LLP, Hyderabad at the total cost of Rs. 23,95,365/- (Rs. Twenty Three Lacs Ninety Five Thousand Three Hundred Sixty Five Only) including Taxes and Duties (customs, GST etc.) with one years standard warranty and installation and training performed on site by a LCGC specialist with other terms and conditions state in his offer under DST – FIST Project Budget Head (4/256).

"Resolved, further that payment be released only after satisfactory installation, testing and training of above instrument."

National Insurance Company Limited at the total cost of Rs. 35,95,066/- with other terms and conditions state in his offer for SVNIT, Students and expenditure will be debit from the budget head 6/43 - premium for students medical insurance.
- Reso. 7: The Dean (Student Welfare) briefed the committee that due to COVID0-19 nationwide lockdown, the process for tendering for Group Mediclaim Policy for SVNIT Students couldn't be made. However, as per provisions of existing Group Mediclaim Policy of M/s National Insurance Company Limited, the policy may be renewed as per the rate of previous year. After deliberation, the committee recommended to:

"Resolved to recommend to approve the proposal of Chairman - Committee for Group Mediclaim Policy of SVNIT students for the year 2020-21 from M/s National Insurance Company Limited at the total cost of Rs.26,75,337/-(Rupees Twenty Six Lakhs Seventy Five Thousand Three Hundred Thirty Seven only) including all taxes (for 4011student @ pro rata basis of Rs.667/per student per year with other terms and conditions stated in their offer from the budget head 6/43 (premium for students medical insurance). Further payment for newly admitted students be made as per pro rata basis in due course of time as per requirement."

"Resolved, further that, immediate payment should be released for Group Medical Coverage Policy for SVNIT students for the year 2020-21 to M/s National Insurance Company Limited (for 4011 students @ pro rata basis of Rs.667/- per student per year) by issuing work order with the advance payment cheque so that the policy period will be effective from July 22, 2020 for all existing students."
