ACTIVITY 1 : "Agriculture and Entrepreneurship" workshop at SVNIT, Surat

Date: 03/09/2019

**Objective of activity:** Student interaction with "Krushi Vigyan Kendra" (KVK) Surat about agriculture and entrepreneurship

**Description:** Dr. Janaksinh K. Rathod, Dr. Rakeshbhai, Dr. Shehulbhai and Dr. Bhaktiben from Krushi Vigyan Kendra, Surat has invited to take a workshop on "Agriculture & Entrepreneurship" for students of SVNIT, Surat. The aim of workshop is to provide knowledge about agriculture and entrepreneurship in agriculture.

- 1) Dr Janaksinh K. Rathod has spoked about successful farmers stories and their good earnings per annum. They had also said that Krushi Vigyan Kendra is available in every districts of the India and all we can take solutions of various problems arising in farming. They had also explain the benefits of doing Cow based natural organic farming and how to earn more from certification and doing export.
- 2) Dr. Bhakti Madam has given knowledge about Horticulture and said how to become successful farmer from crops like Fruits, Vegetables, Spices, Medicinal plants and Flowers.

They had also suggest to do season wise farming so that crop yield can be maximum.

- 3) Dr. Shehul Sir has suggest to farmers of adopted villages to do farming of such crop which can grow in coastal alluvial soil and saline bore well water.
- 4) Dr. Rakesh Sir has explain various insecticides and pesticides and said for adopting Cow based organic farming instead of Urea and DAP chemical fertilizers.

**ACTIVITY 3 :** Participating Institute Meeting at SVMIT, Bharuch

## Date: 15/09/2019

**Objective of activity:** To review the work progress status from all Participating Institutes and solving various issues / problems arised from PIs of Regional Coordinating Institute SVNIT, Surat

**Description:** Regional Coordinating Institute SVNIT, Surat has organized the Participating Institutes Meeting on 15<sup>th</sup> September, at Shri S'ad Vidhy Mandal Institute of Technology (SVMIT), Bharuch. Total 10 PIs have participated in meeting.

## The minutes of the meeting are as follows:

- 1. Dr. K. D. Yadav ( UBA Regional Coordinator ) had heartily welcomed to all Participating Institutes Coordinators and Representatives.
- RCI UBA Coordinator inform that all PIs should submit the monthly progress report within 15 days of next month so that RCI SVNIT can timely submit the Quarterly, Half Yearly and Annual work progress report to National Coordinating Institute, IIT Delhi
- 3. RCI UBA Coordinator have explained various 8 themes for Rural Development by Unnat Bharat Abhiyan, and suggest to do working in at least one or two theme properly. The themes are as follows
  - 1. Agriculture & Organic Farming
  - 2. Water Management & Cleanliness
  - 3. Rural Education
  - 4. Sustainable Energy
  - 5. Health & Environment
  - 6. Livelihood & Entrepreneurship
  - 7. Government Schemes Implementation
  - 8. Basic Amenities
- 4. Query raised by the PIs that adoption of 5 villages is compulsory or not and what activities we can spent the money Rs. 10,000 received per village from IIT Delhi.
- 5. Dr. Manish K. Rathod ( UBA Regional CO-coordinator) has explained the benefits of various Government schemes and explained to all PIs that first learn about all Government Schemes and then do awareness camps / workshop at village community level.
- 6. Coordinator of GIDC Degree Engineering College, Navsari has told about issues related to no proper implementation of Pension Yojana and no awareness in villagers about the government schemes and for that they had requested to Dr. K. D. Yadav. And Dr. K. D. Yadav has replied that for solving such kind of issues there must be a reporting by all the Collectors and D.D.Os so that Unnat Bharat Abhiyan can run effectively.
- 7. SVNIT, Surat is planning to organize 5 day Faculty Development Program at SVNIT Surat with Mahatma Gandhi National Council of Rural Education (MGNCRE)

Hyderabad, tentatively on 14<sup>th</sup> -18<sup>th</sup> October, 2019 and invite all PIs in this 5 days FDP and said that all the expenditure will be provided by MGNCRE.

- Dr. Manish K. Rathod and Dr. Shweta N. Shah has given information about RCI SVNIT is planning to organize a 2 day workshop at SVNIT, Surat with RuTAG Centres IIT Delhi, IIT Bombay, IIT Madras.
- RCI SVNIT, Surat will give prize worth Rs.50,000 to one Participating Institutes among all PIs who give best annual performance; subject to approval from NCI – IIT Delhi.
- 10. Coordinator of GIDC Degree Engineering College, Navsari has told about issue that they want a defined guideline for spending of Rs. 10,000 per village survey fund.
- 11. Dr. Gajanan G Kalyankar coordinator from UKA Tarsariya University has told that we should keep one common certificate and it will be distributed category A, B, C wise to all participating students in Unnat Bharat Abhiyan. And RCI SVNIT will send the certificate design to all PIs soon.

**ACTIVITY 4 :** "Khedut Kalyan Karyashala" means "Farmer Welfare Workshop" at Suvali Village

### Date: 18/09/2019

**Objective of activity:** To give the solutions on pesticides and insecticides, season wise cropping style and other issues related to crop yield.

**Description:** The team from Krushi Vigyan Kendra and Sarpanch Shri Nayanaben Rathod has introduced themselves at starting of meeting. After introduction taken from all farmers, we have visited the farm of Mr. Dhansukhbhai. We have visited farm of Bringle, Dudhi, Bhinda, Karela, Choli, Guvarsingh, Tindora, Mula and Mango trees. During visit we have found various type of diseases and pests and insects available in plant and which are responsible for low crop yield.

Dr. Rakesh sir and Dr. Shehul sir has given solution of available green pesticides and insecticides and given the guidance to doing Cow based organic farming and benefits of organic farming instead of chemical farming. Dr. Bhakti ben has explain to do seasonal

farming and suggest to do not take unseasonal crop. Team from KVK has also suggested to all farmers for Soil Testing and water testing because of salinity problems.



**ACTIVITY 5:** Testing of agriculture water supply from 10 different farms from Junagam Village

Date: 19/09/2019

**Objective of activity:** Checking the quality of agriculture water supply

**Description:** As our all adopted 5 villages are near Arabian Sea, the available ground water from all agricultural farm is saline and salty. There for we are going to test the agriculture supply water from 10 different farms and taking samples into Environment lab, SVNIT, Surat. All the test practices has done under guidelines given from Dr. K. D. Yadav sir and tests were performed by M.Tech student Mr. Krishna Kumar Avshula. Based on these we will design the filter for agricultural water supply.

**ACTIVITY 6:** Visit the meeting of Organic Produce Certification at Surtapi Organic Store, APMC Market, Krushi Bazar, Surat

#### Date: 21/09/2019

**Objective of activity:** To get knowledge about Organic Crop certification and Export business of Organic Agricultural Crops and Products

**Description:** We have attended the general meeting on organic certification & export organized by one of the Organic Store in Surat city "Surtapi" at APMC Market, Surat. Mr. Raman bhai (Ex-Chairman) of Gujarat Organic Products Certification Agency.

Mr. Raman bhai has given the introduction and explain the process of getting of Organic Certification of farmers farm. They had explained that the certificate is not about on one crop or one vegetable or one fruit, the certificate is regarding the system and methodology of doing Cow based farming. They had also explained the fees and how to register (1month) and C1 type (13<sup>th</sup> month inspection from certificating agency team) and C2 stage (25<sup>th</sup> month inspection from certificating agency team) of certification. And they have explain the benefits of certification in export business.

Mr. Raman bhai has agree to do workshop at village community level and we will organize the workshop on "Organic Certification and Benefits" for all farmers of all 5 adopted villages.



**ACTIVITY 7:** Visit the Jilla Panchayat School of all 5 adopted villages for upcoming event "Plastic Free Village"

#### Date: 24/09/2019

**Objective of activity:** To circulate the letter of "Plastic Free Village" campaign. And Computer lab facility survey in all 5 Government schools of 5 villages.
