INTRODUCTION OF PMJDY

- Hon'ble Prime Minister Shri Narendra Modi has launched PMJDY on 28th August, 2014
- Slogan of the scheme: “Mera Khata, Bhagya Vidhata” means “My account bring me good future”
- **AIM** : To provide Bank Account with all services like Debit Card, Banking services, savings, transactions, Insurance, Pension etc. to all People of India.
- Eligibility : Any person having age more than 10 years can open account under this scheme.
 - **The Mission Coordinator: Ministry of Finance, Government of India**



NECESSARY DOCUMENTS REQUIRED FOR OPEN JAN DHAN ACCOUNT

- Adhar Card, If Adhar Card is available, there is no need of any other documents.
- If Address has changed, no need of current address proof.
- If Adhaar Card is not available, need to provide any one of the below Government document
 - A. Voting ID /
 - B. Driving Licence /
 - C. Pan Card /
 - D. Passport /
 - E. MGNREGA Card
- Note: In above document, the address given in proof will be considered as address proof of account holder.



IMPLEMENTING ORGANIZATIONS & BENEFITS

- **Implementing Organizations:** National Banks, Private Banks, Cooperative Banks.
- **Benefits:**
 - 1. Interest on savings amount
 - 2. Accidental insurance of Rs. 10 Lakh
 - 3. No need of any minimum requirement, however some amount being kept for debiting whenever is require.
 - 4. Life insurance of Rs. 30,000
 - 5. Amount is transferable throughout the India.
 - 6. Beneficiary amount of Government scheme will directly credit in these account.
 - 7. Overdraft facility will be provided after satisfactory transactions of last 6 months.
 - 8. Pension and insurance facilities.



ROLE OF UNNAT BHARAT ABHIYAN PARTICIPATING INSTITUTE

- **Step 1:** Visit and meeting with near by Bank manager understand the PMJDY Scheme.
- **Step 2:** Conduct surveys and identify the need of PMJDY in UBA adopted villages.
- **Step 3:** Work with Gram Panchayat & Taluka Pnachayat / District Panchayat Department for implementation of PMJDY scheme in adopted UBA Village cluster.
