

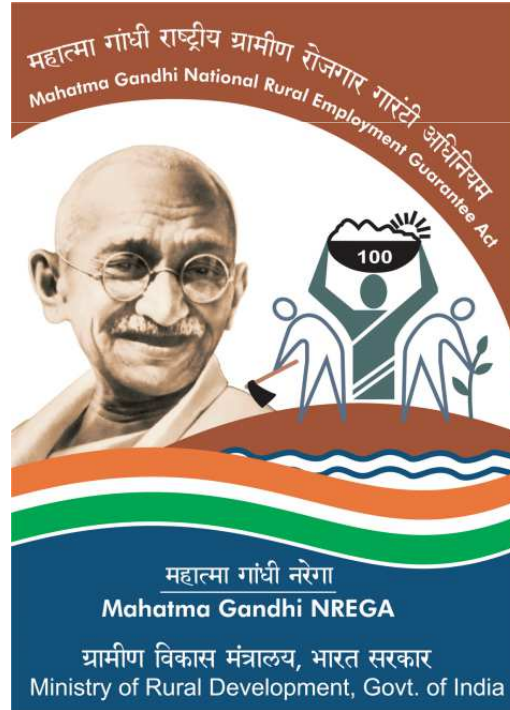

INTRODUCTION



An Act to provide for the enhancement of livelihood security of the households in rural areas of the country by providing at least 100 days of legally guaranteed wage employment in every financial year to every household whose adults volunteer to do unskilled manual work



- The Mission Coordinator: Ministry of Rural Development, Government of India



ABOUT MGNREGA

- MGNREGA Act provide legal guarantee for at least 100 days of employment every year at minimum wages for at least one able-bodied person in every rural poor household.
- Any member of rural household family can apply for issuing of the JOB CARD to respective Gram Panchayat.
- Job Card holder demands work allotment to her/him and within 15 days, they must got the work from Sarpanch, Panchayat Ward Members, Self Help Groups
- The average per day wage rate for unskilled work under the Mahatma Gandhi National Rural Employment Guarantee Scheme will rise 11 per cent from ₹182 to ₹202 for the financial year 2020-2021



ROLE OF UNNAT BHARAT ABHIYAN PARTICIPATING INSTITUTE

- **Step 1:** Visit and meeting with District Coordinator of MGNREGA Department at **District Rural Development Agency (DRDA)**
- **Step 2:** Get knowledge on scope of work and implementation process of MGNREGA Act
- **Step 3:** Conduct surveys and identify the need of MGNREGA in UBA adopted villages.
- **Step 4:** Work with Gram Panchayat & MGNREGA Department, DRDA Office for implementation of scheme.
